**WHEREAS**, the Borough of Mendham (“Borough”) and the Board of Education of the West Morris Regional High School District (“Board of Education”) desire to enter into an agreement with regard to the hiring of a School Resource Officer (“SRO”) to work at the West Morris Mendham High School; and

**WHEREAS**, the Borough shall supply the SRO, who shall be an officer of the Borough Police Department; and

**WHEREAS**, the Board shall pay the sum of \$43,467.30 to the Borough as a contribution to the salary of the SRO for the 2018-2019 school year; and

**WHEREAS**, the Board and the Borough have memorialized their agreement for the SRO in an Interlocal Services Agreement;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Borough Council of the Borough of Mendham, County of Morris and State of New Jersey that the Mayor and Borough Clerk are hereby authorized to execute the Interlocal Services Agreement between Mendham Borough and the Board of Education of the West Morris Regional High School District Regarding a School Resource Officer for West Morris Mendham High School, which is attached hereto and made a part of this Resolution.

**BE IT FURTHER RESOLVED** that a certified copy of this Resolution be provided to the Board of Education of the West Morris Regional High School District.

This Resolution shall take effect immediately.
