AMENDMENT TO MASTER PLAN 2006 (HISTORIC PRESERVATION PLAN ELEMENT)

It is proposed that the following amendatory language be added as the concluding section of page VII-8 of the Borough Master Plan 2006:

HISTORIC DISTRICT EXPANSION

"On March 9, 2009, the Mendham Borough Planning Board passed a motion to send a recommendation to the Borough Council that the Mendham Historic District Overlay Zone be amended to include new properties and adjustments as follows:

Block 1904, Lot 4 - 1 Hampton Road Lot 5 - 3 Hampton Road

Lot 6 - 5 Hampton Road Lot 7 - 7 Hampton Road

Lot 8 - 9 Hampton Road

Lot 9 - 4 Bridge Street

Block 1401, Lot 7 - 63 East Main Street

This amendment is known as Phase 1 of the Historic District Expansion. It aligned the Borough's existing Historic District Overlay boundary with the boundary of the Borough's existing National Historic Register listing.

On September 15, 2009, the Planning Board, after notice and public hearing, duly adopted an amendment to the Master Plan to this effect. Subsequently, on December 7, 2009, the Borough Council duly enacted a zoning ordinance amendment to the Mendham Historic District Overlay Zone consistent with the Master Plan amendment.

By letter to Mayor Neil Henry, dated March 23, 2011, Dennis Bertland, the Borough's Historic Preservation Consultant, following study, consultation with the State Historic Preservation Office, interim reports to the Planning Board and Historic Preservation Commission, and a public information meeting, recommended a Phase 2 expansion of the Mendham Historic District Overlay Zone.

After considering Mr. Bertland's March 23, 2011 recommendation, the Planning Board wishes to further amend the Master Plan to provide for the inclusion of the following properties within the boundary of the Mendham Historic District Overlay Zone as Phase 2:
