ADMINISTRATOR'S REPORT

Ms. Bushman provided a copy of her Administrator's Report dated October 28, 2019 to the Mayor and Council. She reported that Resolution #154-2019 adopted by the Council approved the ACH Agreement with Provident Bank for online payments, which she anticipated would go into effect in November. She also reported that Lisa Smith completed the Planning and Zoning Administration coursework and has received Board Secretary certification from the state.

There was no further Council discussion concerning the Administrator's Report.

COUNCIL COMMITTEE REPORTS

Finance [Standing Committee of the Council]

Council Member Badal was absent. There was no Finance Committee report.

Board of Health

Council Member Andrew reported that the next meeting of the Board of Health will be held on November 6th. He further reported that the Bernardsville Department of Health will be providing free rabies vaccinations on November 9th and reported that the Bernardsville Municipal Alliance will be sponsoring a presentation on e-cigarettes and vaping. Details for these programs are provided on the Board of Health webpage.

Recreation and Parks [Standing Committee of the Council]

Council Member Andrew reported that the Recreation Committee held its meeting on October 17th. Topics discussed included the need to require reservations for use of the turf soccer field, the tennis court rehabilitation project, and a proposal for an outdoor winter ice rink. A dog park will not be pursued.

Board of Education

Council Member Andrew reported that Resolution #157-2019 adopted by the Borough Council approved the shared service agreement with the Mendham Borough Board of Education for snow plowing and lawn mowing services. The Board of Education will pay the Borough costs associated with providing the services.

Public Safety [Standing Committee of the Council]

Council Member Andrews reported that today is National First Responders Day and provided thanks and prayers to all volunteer and paid first responders serving the public. He also reported that the five AED defibrillators have been mounted and installed by the DPW. Council Member Andrews further reported that the Office of Emergency Management held its meeting on October 30th at which time the OEM Coordinator distributed copies of the Borough's OEM Plan.

Council Member Andrews also briefly reported on the Public Safety Committee's recent meeting with the Bernardsville Department of Health staff. An overview of public health services provided was discussed. A class on storm preparedness for seniors will be scheduled in the near future. Lastly, he reminded everyone that the Firehouse fundraiser will be held on November 2nd and the Veterans Celebration will be held on November 8th at the Pastime Club. He encouraged everyone's participation in these events.

Personnel [Standing Committee of the Council]

Council President Sharkey reported that the Personnel Committee will meet next week. Several personnel issues are under review.

Public Works and Utilities [Standing Committee of the Council]

Council Member Kelly reported that the DPW Superintendent requested quotes for the replacement of the Firehouse garage doors and also reported that the renewal lease for the Petsch House is being negotiated.

Land Use [Standing Committee of the Council]

Council Member Reilly had nothing new to report.

ECOSST Committee

Council President Sharkey reported that he attended the annual New Jersey Shade Tree Federation conference and received continuing education credits, which are required as part of the Borough's Tree City, U.S.A. designation. He also mentioned that the DPW is currently performing the fall planting of street trees.

Council President Sharkey further reported that the National Wildlife Foundation sponsors a Community Wildlife Habitat program that promotes wildlife-friendly practices in communities through the use of native trees and plants, as well as programs that help reduce or eliminate the use of pesticides and chemicals. The ECOSST Committee will be looking into this nationally-recognized program.

Council Member Reilly reported that members of the ECOOST Committee recently walked the Scott Farm property with Chris Neff of the Audubon Society to determine possible options for the use, conservation or preservation of the property. A proposal for a wetlands delineations study will be submitted to the governing body. He also reported that knotweed, an invasive species, has been identified along India Brook. The committee is exploring the use of Open Space funding for mitigation and maintenance purposes.

Mayor Serrano-Glassner inquired if the ECOOST Committee would be interested in sponsoring a presentation on back yard composting. Council Member Reilly will bring the Mayor's inquiry back to the Committee for discussion and consideration.

ATTORNEY'S ITEMS

Mr. Semrau advised that the Municipal Excess Liability Joint Insurance Fund (MEL) will be sponsoring a free seminar on the recent legislative changes affecting molestation claims. Elected officials attending the seminar earn a \$250 credit towards the town's MEL premium.

Members of the governing body expressed their interest in attending the MEL seminar. Mr. Semrau will schedule a 1-hour presentation before an upcoming Mayor and Council meeting to allow an opportunity for all elected officials to attend.

MAYOR'S ITEMS

Mayor Serrano-Glassner reported that it is time to begin the nomination and selection process for the 2020 Labor Day Parade Grand Marshall. She requested the Council to begin considering potential nominations for discussion at the November 13th meeting.

Mayor Serrano-Glassner further reported that the Economic Development Committee met on October 23rd. She introduced Neil Sullivan, committee chair, who briefly spoke about three of the committee's initiatives that were discussed: 1. Post Mendham Borough's Market Profile on the website; 2. Prepare and distribute a business survey; and 3. Create a comprehensive listing of local businesses with contact information. Mayor Serrano-Glassner will keep the Council apprised of the committee's progress.

PUBLIC COMMENT – AUDIENCE PARTICIPATION:

Mayor Serrano-Glassner opened the meeting for public comment and invited any member of the public to be heard.

Emily Horihan, 47 Corey Lane, requested permission to install a 9-foot tall menorah at Borough Park and, if the request were to be granted, inquired whether the Department of Public Works would be able to assist with the set up and installation.

Mayor Serrano-Glassner thanked Ms. Horihan and others for offering the menorah display to be part of the community's holiday season displays. She confirmed that the menorah can be installed at the Borough Park gazebo, adjacent to the display of the Borough's Christmas tree and directed Ms. Horihan to submit a field request to initiate the process with Mendham Borough.

Seeing no one wishing to speak, Mayor Serrano-Glassner closed public comment and proceeded with the next agenda item.
