# **DISCUSSION**:

# Best Practices Inventory:

Council President Witczak asked the Council if there were any comments regarding the Best Practices Inventory document that was distributed with the agenda. Administrator Sandman commented that based on the Borough's scores, there would be no lost funding. Councilman Andrus commented that it may be valuable for the future to work on the items that were responded to as a 'no'. He suggested the Borough adopt a 'pay to play' ordinance making the State regulations more restrictive. He further commented on #7 requiring governing body members to attend a government sanctioned course; #11 maintaining an account manual and internal communications to the staff and #15 separation of duties in the finance office (which appears on the annual audit each year) and a fixed asset report. Councilman Andrus expressed his opinion that these should be considered for the future. Administrator responded that she would consult with the CFO and Auditor on the account manual but felt there were not enough employees to consider separation of duties' or enough money for the Borough to do a fixed asset report.

Councilman Andrus noted the 'Edmonds' system was discussed in the past as a replacement of the present "Vital' system used in the Borough. Administrator Sandman does not support the change to 'Edmonds'.

Councilman Andrus commented on an email request from Kevin Melly regarding the renewal of the Mendham Co-Op lease. Mr. Andrus stated that he would be willing to meet with Mr. Meely to discuss the lease but the approval of Council is needed for any agreement. After a brief discussion it was decided to ask the Administrator to meet with Mr. Melly and determine what he is looking for and this matter will be discussed in closed session.

Councilman Witczak reported the ongoing process of hiring to fill 2 vacant positions at the Department of Public Works. He strongly suggested getting an employee with tree climbing/cutting experience. He continued to report on the per diem hiring for snow plowing and that the employee who was hurt and required surgery is doing well.

#### **ATTORNEY ITEMS:**

Att. Semrau reported the on his preparation of an amendment to the Wind/Solar Ordinance that was introduced. This amendment will address the inherent dangers to firefighters that have become apparent. He suggested that the revisions be considered at the next meeting which will address the dangers and require precautions and notification necessary for the protection of firefighters. Mr. Semrau attended a meeting on October1st with regard to the transition to the Chester Borough court and noted that the process is on track.

MAYOR'S ITEMS: Mayor Henry was not present at this meeting.

#### **PUBLIC COMMENT:**

David Sprandel, 18 North Linden Lane, offered congratulations to everyone for Mendham being declared #1 place to live in the State of NJ.

Chief Libertino reported that he will be sending a representative from PD to a Morris County meeting on a program similar to 'e-tickets'. He will report back to the Council when more information on the program is know and the costs involved as well as if it being considered mandatory.
