# November 12, 2020 MINUTES

### **CALL TO ORDER**

### **2020 Best Practices Inventory**

Mr. Semrau advised that all municipalities are required to file a completed Best Practices Inventory to the Division of Local Government Services each year. A municipality must receive a minimum score of 16 on the Inventory to receive its full "State Aid" payment. There are 29 scored questions in the categories of "Core Competencies" and "Best Practices."

[Borough Clerk's note: LFN 2020-20 requires the municipality's Chief Finance Officer and Chief Administrative Officer to complete and file the Best Practices Inventory with the state on or before November 3, 2020 and also requires the Municipal Clerk to certify with the state that the Best Practices Inventory, and the results thereof, was discussed or will be discussed at a public meeting and referenced in the meeting minutes.

The Chief Finance Officer and Chief Administrative Officer filed the Best Practices Inventory with the state on October 30, 2020. The Borough Clerk distributed a filed copy of the Best Practices Inventory to the Governing Body together with the November 12<sup>th</sup> Council agenda packet and subsequently certified with the state that the

### **ADMINISTRATOR'S REPORT**

Ms. Bushman distributed a copy of her Administrator's Report dated November 12, 2020. She mentioned that she is preparing a preliminary 2021 budget, which is being reviewed by the Finance Committee and also confirmed that the Morris County's Open Space Trust Fund Committee has recommended a \$220,000 preservation grant to Mendham Borough for the acquisition of the United Methodist Church property.

### **COUNCIL COMMITTEE REPORTS**

### Finance [Standing Committee of the Council]

Council President Badal reported that capital and operating budget requests for the 2021 calendar year have been reviewed and mentioned that the preliminary 2021 budget will come in under the 2% cap. Some capital projects may be postponed until 2022 so that Mendham Borough's remaining debt service may be paid off, making the Borough debt-free.

### **Board of Health**

Council Member Andrew reported that the Board of Health will be meeting on December 2<sup>nd</sup> and had nothing new to report.

### **Recreation and Parks [Standing Committee of the Council]**

Council Member Andrew reported that Recreation Committee will be meeting on November 19<sup>th</sup> and had nothing new to report.

### **Board of Education**

Council Member Andrew reported that the Mendham Board of Education will be meeting on November 17<sup>th</sup> and that the next meeting of the West Morris Regional High School District Board of Education will take place on December 7<sup>th</sup>.

### **Public Safety [Standing Committee of the Council]**

Council Member Andrews reported that a temporary traffic light has been installed on Ironia Road at West Main Street for the pending the repair of the bridge on Mountainside Road and further reported that the replacement of the Cold Hill Road water main line is expected to be completed in two weeks.

Council Member Andrews announced that police headquarters will once again be a collection point for the Marine Corps Toys for Tots program. New, unwrapped toys can be dropped off before December 10<sup>th</sup>.

### **Personnel [Standing Committee of the Council]**

Council Member Martin had nothing new to report.

### **Public Works and Utilities [Standing Committee of the Council]**

Council Member Kelly reported that the new asphalt hot box has been delivered to the DPW and further reported that DPW crews will be installing a new fence at the Borough Park playground, which he mentioned has been recently repaired and improved by the public works department.

### Land Use [Standing Committee of the Council] and ECOSST Committee

Council Member Reilly reported that the Land Use Committee briefly met tonight and had nothing new to report.

### **ATTORNEY'S ITEMS**

Mr. Semrau had nothing new to report. He advised that attorney Sue Sharpe will be presenting the Municipal Excess Liability Joint Insurance Fund (MEL) webinar on best practices. Elected officials attending the seminar earn a \$250 credit towards the town's MEL premium. Mr. Semrau will provide the Administrator and Borough Clerk with information and details to pass along to the governing body.

### **MAYOR'S ITEMS**

Mayor Serrano Glassner reported that holiday events will be limited this year in Mendham Borough due to COVID-19 restrictions and announced that Borough events will be posted on the Borough's website and social media accounts.
