# ADMINISTRATOR'S REPORT

Ms. Bushman provided a copy of her Administrator's Report dated November 25, 2019 to the Mayor and Council. She reported that the employee holiday party is scheduled for December 13<sup>th</sup> and confirmed that Borough offices would close to the public at 12:00 noon. A notice informing the public that Borough offices will be closed will be posted on the website and social media.

Mayor Serrano-Glassner noted that the Administrator reported a savings to date in the annual compensation paid for the Tax Collector position.

Council Member Reilly inquired about the reported damage to the electric service for the Scott Farm property. It was reported that the Public Works Department filed an insurance claim. It is not known who caused the property damage. The matter was referred to the ECOOST Committee for further review and recommendation.

# Finance [Standing Committee of the Council]

Council Member Badal reported that the Finance Committee met earlier in the day and discussed the 2020 Salary Range Ordinance, 2020 salary recommendations, and professional service agreements. The committee will be reviewing Capital budget requests that have been received.

# **Board of Health**

Council Member Andrew reported that the next meeting of the Board of Health will be held on December  $5^{th}$ .

# Recreation and Parks [Standing Committee of the Council]

Council Member Andrew reported that the Recreation Committee met on November 21<sup>st</sup>. Topics discussed included the Holiday Decorating Contest and the Holly Trail. The construction of the Gaga Pit will begin on November 29<sup>th</sup>.

# **Board of Education**

Council Member Andrew had nothing new to report.

# Public Safety [Standing Committee of the Council]

Council Member Andrews reported that the OEM met on November 18<sup>th</sup> and cleared all open items in the Borough's Emergency Operating Plan. The Public Safety Committee discussed formalizing mutual aid agreements for EMS and First Aid Squad services with neighboring communities and also discussed re-establishing a CERT (Citizen Emergency Response Team) for the Borough.

Council Member Andrews further reported that a resident had brought to his attention that a street light is needed for the crosswalk at East Main Street and Orchard Street. The police department will submit a request to JCP&L. He also confirmed that letters were sent out to Orchard Street households to survey whether onstreet permitted parking should remain in place. The Police Chief will follow up. Lastly, he inquired whether the Administrator or the Board of Health would be able to coordinate a storm preparedness class.

# Personnel [Standing Committee of the Council]

Council President Sharkey had nothing new to report.

# Public Works and Utilities [Standing Committee of the Council]

Council Member Kelly reported that the Public Works crews have installed holiday lights on the Phoenix House and further reported that the reduction of the Firehouse water line from 4-inch diameter to a 2-inch diameter will reduce water costs.

# Land Use [Standing Committee of the Council]

Council Member Reilly was absent.

# **ECOSST Committee**

Council Member Reilly had nothing new to report.

# **ATTORNEY'S ITEMS**

Mr. Semrau advised that an update on the Borough's affordable housing matter will be provided for closed session.

# MAYOR'S ITEMS

Mayor Serrano-Glassner followed up on nominations from the Borough Council for the selection of the 2020 Labor Day Parade Grand Marshall. She confirmed that she had contacted former mayors for their input.

Three additional nominations were added by members of the Council. Mayor Serrano-Glassner asked that the Borough Clerk maintain a listing of all nominations for future Council consideration.

Upon discussion, there was a consensus by the Borough Council to select former Mayor Richard Kraft as the 2020 Labor Day Parade Grand Marshall.
