ADMINISTRATOR REPORT

The Administrator's report was distributed to the Mayor and Council previously.

Councilman Badal requested clarification regarding payment for the new firehouse roof. Mr. Merkt confirmed that partial payment had been made and that final payment will not be remitted until after inspection.

Councilman Sharkey asked whether any resolution has been reached regarding incidents involving Daytop residents. Mr. Merkt stated that he and Chief Libertino met with Daytop management to inform them that it is their responsibility to fix the issue. He further stated that the state imposed oversight regulations that hinder Daytop's ability to contact parents should a resident leave the property without authorization. Councilman Andrus was adamant that an increase in overnight supervision is required as part of any solution suggested by Daytop officials.

The Mayor thanked Mr. Merkt along with Councilman Andrus for the state of the initial budgets and the efficiency of the budget meeting.

COUNCIL REPORTS, OLD & NEW BUSINESS

Councilman Andrews – The proposed outdoor dining ordinance and the revised generator/AC pad language are scheduled to be introduced at the Council meeting on January 18, 2016.

Councilman Andrus – The budget is in good shape and the department head meeting went well. Mr. Merkt will be scheduling a Finance Subcommittee meeting for prioritization of capital expenditures.

Councilman Badal – A vote will be taken at tonight's meeting for the Police Secretary candidate and work continues on staffing the Zoning Department. The Mayor indicated that he has been contacted regarding lack of staffing and Mr. Merkt stated that he intends to have a plan in place by the end of December.

Councilman Sharkey – Holly Trail was a success and field allotment is underway. A photo contest is being held to encourage tree maintenance in the Borough. Residents can submit a photo of their favorite tree and winners will received one of 2,000 seedlings being provided based on the Borough's Tree City USA designation.

Councilman Witczak – The DPW has created a mockup of the Borough Park scoreboard and placement (location and height) is still being considered. Mr. Merkt requested that the Council take a few minutes to stop at the park to assess the current location and report back with any comments.

Councilwoman Daly – The Public Safety Committee and DPW continue to explore options for snow shoveling of Borough sidewalks.

ATTORNEY ITEMS

Ms. Thomas stated that the firm continues to monitor COAH status.

MAYOR'S ITEMS

PUBLIC COMMENT

Mayor Henry opened the floor to comments/questions from the public. Mr. David Sprandel, North Linden Lane, complimented the newly-installed hand railings on the Phoenix House front stairs. He further asked Councilman Sharkey whether the seedlings being given out were fruit trees and Councilman Sharkey confirmed that they were shade trees. Mr. Sprandel inquired on the status of the puddingstone wall in front of 34 East Main Street. Mr. Merkt indicated that work has begun to repair the wall with like-for-like materials.

Sister Mary Edward, Bernardsville Road, thanked the Mayor and Council and expressed sincere gratitude for the adoption of Ordinance #7-15.

Hearing no further comments, the Mayor closed the public portion of the meeting.
