#### **ADMINISTRATOR REPORT**

The Administrator's report was distributed to the Mayor and Council previously.

Councilman Badal inquired whether the Borough's outgoing phone message could be reordered such that more frequently called departments were closer to the beginning of the recording. A brief discussion followed regarding phone system options and Mr. Merkt agreed to look into the matter.

Mr. Merkt agreed to obtain procurement cards for use by Borough employees.

#### **COUNCIL REPORTS, OLD & NEW BUSINESS**

Councilman Andrews – The Zoning Officer candidate turned down the Borough's offer and a second advertisement will be posted on <a href="www.njslom.org">www.njslom.org</a> and <a href="www.njclerks.org">www.njclerks.org</a>. The Land Use Committee continues to refine the Outdoor Dining ordinance and Ms. Kaye will send the current version to Mr. Semrau for legal review.

Councilman Badal - no report.

Councilwoman Daly – The Public Safety Committee has already held a few meetings and the next regular-scheduled meeting is June 15, 2016. The Committee is still waiting for the OEM Coordinator and Fire Department to resolve chain-of-command questions.

Councilman Sharkey – Mr. DiBisceglie was commended for his work on the summer camp program. His efforts have resulted in higher-than-anticipated enrollment and financials are up 7%. The recreation booklet will be out by April  $1^{\rm st}$  and Grand Marshal nominations are being considered. Mayor Henry advised Councilman Sharkey to gather information for each candidate in order to narrow the criteria for selection.

Councilman Witczak - excused.

Councilman Andrus – A budget meeting will be held next week to finalize capital expenditures, tax rate and fund balance. Refunding bond ordinance #02-15 will result in savings of \$166K over the next six (6) years. Court costs are down \$30-40K from last year.

# **ATTORNEY ITEMS**

Mr. Semrau stated that the Affordable Housing litigation is pending and is expected to be heard in April. He confirmed that the Borough is currently in compliance and expects the matter to be decided within 30 days.

# **MAYOR'S ITEMS**

Mayor Henry indicated that two (2) residents have expressed interest in joining the Historic Preservation Commission which would fill all positions. He further announced that the April 4, 2016 Special Meeting with the Board of Education to discuss the Feasibility Study has been confirmed. The Mayor asked that the Council and other interested parties view the Haber presentation on MendhamTV prior to the meeting.

Mayor Henry opened the floor to comments/questions from the public. Hearing none, the Mayor closed the public portion of the meeting.
