#### MINUTES OF A MEETING OF THE MAYOR AND COUNCIL

## **CALL TO ORDER**

Mayor Henry called the May 20, 2013 meeting of the Mayor and Council to order at 8:00p.m. in the Garabrant Center, 4 Wilson Street, Mendham, New Jersey.

## **INVOCATION AND FLAG SALUTE**

Mayor Henry offered a moment of silence meditation, followed by the Pledge of Allegiance.

## **DISCUSSION**:

#### Girl Scout Troop 6: (Taken out of sequence)

Catherine Ruska presented the troop to the public and the Council. Troop 6 recited the Girl Scout pledge and scout individually gave a report on how they accomplished the goal of educating and instilling awareness of adopting an animal from a shelter vs. a pet store or breeder. The girls of Troop 6 attended a Mendham Borough school assembly promoting their slogan, "Adopt Don't Shop"; collected food and supplies; produced a brochure "Animal Licensing and Control Information; and visited Pet Value during an animal rescue organization adoption event. It was evident that the girls of Troop 6 were passionate about this project and gave completely of their time and energy and truly deserving of the "Bronze Leadership Award". The Mayor and Council thanked them all for a job well done.

## **Board of Chosen Freeholders-Freeholder Hank Lyon:**

Copies of the 2013 Morris County Budget were distributed to the governing body and copies available for the public.

Freeholder Lyon noted that the budget before them included 39 towns in Morris County.

His presentation included the 2013 budget highlights noting the actual spending reduced by \$2.3M; the Operating Budget Overview; highlighting savings in the Pension/HealthCare due to reform by Governor Christie and health care redesign/salaries/outsourcing of housekeeping, laundry, food services resulting in the first zero increase in 15 years.

Morris County Services provide for senior citizens citing a wide variety of human/senior service programs that are available. It was further noted that the County allocates fund to the County College of Morris, Morris County School of Technology and the Morris County Park Commission. There was a pie-chart provided showing how the millions of dollars are spent by the County. The presentation supported the financial strength that the County is maintaining by a lower budget, reduction in salaries/employees, reduction in health and pension costs, reasonable long-term labor agreements and the use of surplus remain unchanged. The 2013 surplus funds used is actually \$200,000 less than last year noted Freeholder Lyon.

Mr. Lyon reported on debt management and noted an addition to the Public Safety Training Academy, renovations to the Central Avenue Complex and 4 multi-use turf fields as projects presently under construction. He continued with citing some additions to the budget and noted risks for the 2014 future budget. Attached to the handout were additional facts and figures for future reference.

Mr. Lyon commented on the Open Space tax that was instituted and still presently being collected to maintain open space and Historic Preservation. There are discussions presently on whether or not to continue to collect this tax money. Mayor Henry noted that Mendham Borough benefited from the Morris County Trust Grant back in 2003-2004 which was used for maintenance on the Phoenix House and money from the open space tax to maintain the Cosma Track property for passive recreation.

Mayor Henry and Council questioned Mr. Lyon on the high cost of belonging to the County Emergency Dispatch Services. It was further noted that the cost does rise each year. Mr. Lyons responded that the increase for year 2013 was only 1.25% and this is attributed to the inflationary costs citing employee raises of 1.75%. Mr. Lyons did not have the historical data available to respond further, but will consult with another freeholders and obtain this information. He did further respond that only 40% of the municipalities in the County are part of this service but is anticipating that this will change in phases once the Public Safety Training Academy is expanded and can handle additional municipalities.

It was noted that there have been questions from other towns that this service be incorporated in the County taxes collected from municipalities. This is being considered and the goal of the County long term is to dispatch for all the County municipalities.

Councilman Garubo supported by Chief Libertino expressed concern over the level of service in efficiency being realized over the last 2 years. Chief Libertino cited a specific recent incident he encountered. Mr. Lyon will consult with the other freeholders and voice these concerns.
