6. PRESENTATION

West Morris Regional High School District School Board Robert Strobel, President and Thomas Brooks, Chairperson of Finance gave an overview of the upcoming school March 12th election Bond Referendum for Chester Borough, Chester Township, Mendham Borough, Mendham Township, and Washington Township. President Robert Strobel stated that the State would pay \$8 million towards the \$26 million in improvements at West Morris Central and West Morris Mendham. President Strobel highlighted some of the improvements planned for West Morris Mendham. This included installing AC in areas of the high school that do not have it. Technology lab and kitchen updates. Culinary arts room renovations, adding six new workstations. Locker room showers and installation of stall showers for the boy's locker room. Needed roofing and paving. Thomas Brooks, Chairperson of Finance explained that they need the majority vote across all five towns for it to pass. The council and public continued discussion with questions and answering. Mark Van Den Hende of 11 Coventry Rd questioned the timeline of renovations and operating cost. President Strobel felt the installation of AC throughout the school was one of the largest parts of the project.
