HC 34-13: Murphy & Cistaro, LLC – Review of Sign

The applicants had provided the Commission with sign design, fonts, size and location with their application dated November 4, 2013.

Mr. Murphy explained to the Commission that their sign would be 16 inches high and 72.25 inches long. It is double sided and made of a high density polyurethane material. He pointed out that while the sign is shown at the top of the sign post in the photos provided, it will be located at the bottom as that is the location that is assigned to a business located in the rear of the building. The sign will have a matt finish. The background will be black and the letters will be carved in with gold leaf. They would be using the top version submitted with the application where the gold outline is used.

Mr. Cusano noted that the sign was of a different color than those above, but the applicant should be given the option of color. Commission noted that the proposed sign was more in keeping with what they have been requesting. When the other signs change out, they will review those applications for consistency.

Chair opened the meeting to public comment. There being none, the public session was closed.

Mr. Cusano made a motion to approve the application as submitted. Mr. Nicholson seconded.
