## **ORDINANCE #10-2023**

## ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 102, FEES AND RATES, OF THE BOROUGH CODE TO MODIFY CROSS-REFERENCES TO THE SEWER CODE

WHEREAS, § 168-54 of the Borough of Mendham Code governs sewer utility fees and rates for users not serviced by a water system, and § 168-55 governs Sewage System Service Connection Fees; and

WHEREAS, the Borough has become aware that the section number cross-references to §§ 168-54 and -55 in Chapter 102-1, Schedule of fees and rates, should be reversed, and

**WHEREAS**, the Borough desires to amend Chapter 102-1 to make this change, and also to amend Section 1 of Ordinance #08-2023, adopted on April 12, 2023, to reflect § 168-55 instead of § 168-54.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Mendham, County of Morris, State of New Jersey, as follows:

**SECTION 1**. Chapter 102, Fees and Rates, § 102-1, Schedule of fees and rates, §§ 168-54 and -55, of the Borough Code is hereby amended to read as follows:

Chapter/Section	Service	Fee
§ 168-54	Sewer Utility Fee for users for each EDU computed with respect to such building not serviced by a water system	\$167.03 per billing quarter
§ 168-55	Sewage System, Service Connection Fee - Residential/Commercial/Multi-family	\$10,810.00 per EDU (N.J.S.A. 40A:26A-11)

**SECTION 2**. Section 1 of Ordinance #08-2023 is hereby amended to change the section reference in Section 1 from § 168-54 to § 168-55. The rest of Ordinance #08-2023 shall remain unchanged.

**SECTION 3.** If any portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate,

distinct and independent portion, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 4**. All ordinances or parts of ordinances inconsistent herewith are repealed as to such inconsistencies.

**SECTION 5.** This Ordinance shall take effect immediately upon final passage and
