For the Deaf and Hard of Hearing Community

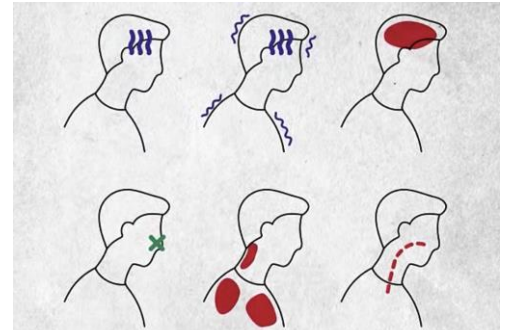
A free emotional support helpline is now available to deaf and hard of hearing New Jersey residents feeling the emotional and mental toll of COVID-19. Call the videophone helpline at 973-870-0677 for free confidential support. Direct communication in sign language will be offered from 9am – 5pm Monday thru Friday by live trained specialists.

Local Health Departments and Long Term Care Facilities

Local health departments (LHDs) are the lead agency for investigating outbreaks of COVID-19 in their jurisdiction. They serve as the primary point of contact with long-term care facilities (LTCF) and assisted living facilities (ALFs) in their jurisdictions and are required to report suspect and confirmed outbreaks immediately to NJ Department of Health (NJDOH) and Communicable Disease Services (CDS).

The NJDOH/CDS assist LHDs in managing these outbreaks by providing guidance on surveillance, reporting, infection control and other recommended measures the facility should take to control the outbreak.

The LHD works with the facility to ensure these recommendations are implemented and to obtain status updates on a daily basis. CDS will review outbreak data, identify areas of concern, provide additional guidance through LHDs, and assist the LHD to elevate areas of concern.



CORONAVIRUS

CDC lists six symptoms that repeatedly show up

The new symptoms, which could appear two to 14 days after exposure, are:

- Chills
- Repeated shaking with chills
- Muscle pain
- Headache
- New loss of taste or smell
- Sore throat

The CDC listed just three before: shortness of breath, cough and fever.

Please stay home if you are exhibiting symptoms.

- **FACE COVERINGS**
Visitors should wear cloth face coverings where social distancing is otherwise difficult to maintain.
- **MAKE SPACE**
Maintain an ideal six-foot distance between yourself and individuals outside of your household.
- **MOVE OVER**
While walking on trails, warn other users of your presence as you pass, and step aside to let others pass.
- **BE PREPARED**
Plan ahead, as parking will be limited to 50% of capacity and restrooms and water fountains are closed. Take your trash home with you.
- **NO GROUPS or ORGANIZED ACTIVITIES**
Organized activities or sports and the gathering of individuals is not allowed.
- **NO PICNICKING**
Picnicking and coolers, chairs, blankets and other related items are not allowed.
- **LEASH AND CURB YOUR DOG**
Dog must be on a leash at all times (5-8.7) and removal of dog feces will be strictly enforced (5-8.9).
- **NO GOLF IN PARKS**
Hitting of golf balls is prohibited (10-15).

 - **Somerset County** – Joint testing site with Hunterdon County at Raritan Valley Community College. 118 Lamington Road, Branchburg, NJ 08876. Drive thru testing by appointment only with valid doctor's prescription. Open May 5th and May 7th from 10 am – 1pm. Subject to change.  - **Morris County** – Drive Through. Located at Morris County Community College. 214 Center Grove Rd, Randolph, NJ 0789. For patients with a doctor's prescription.
