Dear Borough Resident,

Recently the The Borough of Mendham Shade i	Tree Commission evaluated your
neighborhood and proposes planting	on your property
near the curb-line.	

The Mendham Borough Shade Tree Commission is committeed to planting trees in our community. The Tree Planting Program enhances the overall appearance of our community, it also:

- Encourages additional landscaping within the community
- Enhances the appearance of your home
- · Provides a habitat for birds and other wildlife
- Cleans and recycles oxygen improving air quality
- Fosters a greater sense of community pride

Trees are selected based on the following:

- Hardiness of tree species for the specific soil of the area
- Tree's color, texture and form to maximize the potential of street alignments and views
- Space constraints imposed by utility easements, service connections, sidewalks and driveway locations

By weighing these criteria, a detailed plan for the neighborhood is prepared and specific trees are purchashed for each property. Only the healthiest trees available are selected and all trees are inspected by New Jersey's Department of Agriculture and deemed disease and pest free.

Before plantings can begin your approval is needed. Attached is an Authorization Form that asks your permission to proceed with the plantings and how maintenance of the plantings will be handled going forward. Please contact Public Works at 973-543-6535 between 8am – 3pm, Monday – Friday if you have any questions or concerns. With your approval stakes will be placed where the plantings will be located. Once staked, plantings usually occur within 2 weeks.
