MAYOR'S MESSAGE

Mayor Serrano Glassner gave the following Annual Message:

"Welcome and thank you all for joining us this evening.

"A year ago, we gathered dressed in our Roaring Twenties finery and had great hopes for 2020. That party was over quickly but the hangover felt like it went on forever with the many challenges that we faced. I am grateful that we have left last year behind, and hopeful for the clean slate a new calendar brings. We did not pass through the year completely unscathed. We lost friends and family in much greater numbers than should be reasonable to expect. As we move forward and away from the trials of 2020, we should never forget the Mendham Borough residents that we left behind in that storm. Let us take just a couple of seconds here to keep them in our thoughts...

"We did, however, weather the pandemic storm and power outage here in Mendham Borough because we worked together. We have a dynamic group of individuals who sign up and show up for duty regardless of the circumstances -- and they stay on duty until calmness rules. Of course, this includes our professional staff, who after 2020 can now say they have seen it all. This also includes our many professional volunteer residents. All that were involved had to operate in an environment of constantly changing rules, that like so many towns, damaged our local small businesses and stretched our finances beyond what is normal. "I have come to believe these people are some of the most creative and determined people I know. We found PPE when there was none to be had, cared for our residents at the risk of our own health, and found new solutions for complicated problems. My thanks go out to all of you, our everyday heroes, who put in the extra hours, put on the Tyvek suits, listened in on long conference calls, and helped our residents in every way possible.

"I also want to mention our residents and business owners. We have many people who rose to the new challenges of the day. It is our Mendham Borough folks like John Kim of Robinson's who came to our rescue in helping us purchase PPE, and so many others who sewed for new friends, delivered groceries, donated to food banks, and delivered meals to front line workers. You all make up the tone of Mendham, this peaceful place we call home.

"We try to offer the kind of day-to-day life that brings people here to Mendham, a place that represents safety and familiarity. Together we all work towards providing the best services we can and a place that helps us find balance.

"The unrest we saw in our Capitol yesterday is not the kind of balance or democracy we all hope for in America. Yesterday and last night was an echo of the same behavior that we have seen in cities across the country like Portland, Seattle, and New York City, and in Portland's case has gone on for months without end. Here in Mendham Borough, I believe we strive for a life where all members of our community can express their political views in a respectful way that keeps the spirit of democracy alive. The kind of democracy where residents can disagree politically, then get together at the Pub for a beer and give political talk a rest.

"What can we all expect in Mendham in 2021? Hopefully little more uneventful. Some of the projects we are looking to:

Phoenix House restoration

Day camp resuming More recycling events

Expanding our tree planting program Making improvements to our parks

Reconstituting our Economic Development Committee

Merging our land use boards
