ADMINISTRATOR'S REPORT

Ms. Bushman provided a copy of her Administrator's Report dated January 27, 2020. She further reported that the structural analysis report for the Phoenix House has been received and will be distributed to the Council.

Council Member Reilly inquired about the status of the Dean Road speed study. Chief Camoia reported that Dean Road traffic data is reviewed week-to-week. Statistical data is provided in the Police Department's monthly report. Chief Camoia further reported that two digital "Your Speed Is" display signs are requested in the 2020 operating budget and if approved, will be permanently installed on Dean Road, one in the westbound direction and the other in eastbound direction.

COUNCIL COMMITTEE REPORTS

Finance [Standing Committee of the Council]

Council President Badal reported that a Finance Committee meeting will be scheduled to the new fee and rates schedule. He further reported that the committee will be reviewing and analyzing policing services agreements and data of other municipalities.

Board of Health

Mayor Serrano-Glassner reported that the Board of Health met on January 8th. Maureen Walker was appointed Board President and Nancy Rodrigues was appointed Board Vice President.

Recreation and Parks [Standing Committee of the Council]

Mayor Serrano-Glassner reported that a "Stigma Free" 5K run event is being proposed and further reported that the Mendham Borough schools will be initiating new mental health awareness programs for students and parents. She also reported that the construction of the Westfield carriage house has begun and the demolition of the tennis courts is underway. The Food Truck Festival is being planned for the fall.

Board of Education

There was nothing new to report.

Public Safety [Standing Committee of the Council]

Council Member Andrews congratulated Lt. Pirillo and Sgt. Irons on their promotions and thanked Chief Camoia for his efforts in the promotional process. He also thanked Gary Lynch for serving as OEM Coordinator for Mendham Borough.

Council Member Andrews announced that he and Chief Camoia will be available to meet with residents before the Wednesday Council meetings each month to discuss public safety concerns.

In his report, Council Member Andrews provided the following 2019 first responder statistics: the Police Department responded to 18,003 calls (a decrease from 17,697 calls in 2018); the Emergency Squad responded to 447 calls and logged in 13,486 volunteer hours (call responses, training and meetings); the Fire Department responded to 233 calls and logged in 4,776 volunteer hours.

Lastly, Council Member Andrews reported that he will be leading a "Hometown Heroes" veteran banner initiative in Mendham Borough. A fundraising goal of \$750 has been established to purchase 10 customized banners honoring Mendham Borough veterans. Banners will be displayed along Main Street from Memorial Day through Veterans Day. Mr. Semrau was asked to draft an authorizing resolution setting forth an enacting policy for the Hometown Heroes Veteran Banner program.

Personnel [Standing Committee of the Council]

Member Martin reported that the job advertisement for a part-time tax collector had been posted.

Public Works and Utilities [Standing Committee of the Council]

Council Member Kelly was absent.

Land Use [Standing Committee of the Council]

Council Member Reilly had nothing new to report.

ECOSST Committee

Council Member Reilly reported that the ECOSST Committee is planning a technology shredding day and is working with a potential vendor for on-site shredding of computer hard drives, cell phones and personal devices. More information to be provided.

ATTORNEY'S ITEMS

Mr. Semrau advised that the Court approved Mendham Borough's affordable housing settlement agreement. His office will prepare the required action items to establish and implement the affordable housing plan.

MAYOR'S ITEMS

Mayor Serrano-Glassner reported that information will be posted on website providing tips on how to stay healthy through the flu and cold season. She further reported on a recent meeting attended by female mayors in neighboring towns. One of the topics discussed was the 100th anniversary of the Women's Suffrage Movement this year. A July 4th parade float will be organized by the girl scouts.

Appointment to the Board of Health [requires Council approval]

Laura Montenegro Regular Member Term of Office: 01/01/2020 to 12/31/2022 (3 years)

Mayor Serrano-Glassner appointed Laura Montenegro to a 3-year regular member position and asked the Council for a motion to approve.

Council Member Andrews made a motion to approve the appointment of Laura Montenegro to the 3-year regular member position. Motion seconded by Council Member Reilly. Upon a voice vote, the motion was passed unanimously.

Appointment to the Recreation Committee [Mayoral appointments]

Lucie Antonius (Class of 2021) Student Member Term of Office: 01/01/2020 to 12/31/2020 (1 year)

Mayor Serrano-Glassner appointed Lucie Antonius to the Recreation Committee for a 1-year term as a student member.
