7. ORDINANCE FOR PUBLIC HEARING/ADOPTION

#01-2021 AN ORDINANCE OF THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY, ADOPTING AN NJDEP MODEL ORDINANCE FOR STORMWATER CONTROL

A legal notice was published indicating that Ordinance #01-2021 was introduced and passed on first reading at the January 25, 2021 meeting and further indicated that the second reading and public hearing would be held on February 10, 2021 at 8:00 p.m. for consideration of final adoption. At the February 10, 2021 meeting, the public hearing and consideration for adoption was tabled to February 22, 2021 to allow review and comment by the Joint Land Use Board.
