MINUTES

DISCUSSION

Morris County Master Plan – Circulation Element – Mr. Kraft announced that the Circulation Element of the Morris County Master Plan is being updated and proposed that a subcommittee be formed in order to monitor the changes and report back to the Planning Board. He added that the same committee would then oversee work on the reexamination of the Borough Master Plan due in 2016. Mr. Kraft further explained that the update to the Borough Master Plan is conveniently timed as it coincides with the proposed zoning change that is currently being considered for the Sisters of Christian Charity property.

Borough Master Plan Update – Subcommittee Appointment – Mr. Henry, Esq. explained the Master Plan reexamination process and reiterated that changes could be made to accommodate the Sisters' proposal once it becomes more definitive. Mr. Kraft asked for volunteers for the Master Plan Subcommittee and Mr. Sprandel, Mr. Kraft and Mr. Merkt were appointed with Mr. Bradley as Alternate. The subcommittee members agreed to coordinate attendance to the various Circulation Element hearings being held on March $18^{\rm th}$ & $25^{\rm th}$ and April $1^{\rm st}$ & $29^{\rm th}$. Mr. Henry recommended that not more than four (4) Board members attend the same hearing.
