ORDINANCE FOR PUBLIC HEARING/ADOPTION

#04-2021 AN ORDINANCE OF THE BOROUGH OF MENDHAM TO AMEND ORDINANCE 21-99, "AN ORDINANCE OF THE BOROUGH OF MENDHAM TO CREATE A LENGTH OF SERVICE AWARDS PROGRAM"

Purpose: Mendham Borough established a Length of Service Awards Program ("LOSAP") to ensure the retention of members in the Mendham Fire Department and Mendham First Aid Squad and to provide incentives for recruitment of new members. The LOSAP base contribution amounts have not been increased since 1999. This ordinance updates the current base contribution amounts to accurately reflect annual Consumer Price Index adjustments as set forth by statute and by the Director of the Division of Local Government Services.

ORDINANCE FOR PUBLIC HEARING/ADOPTION

#02-2021 ORDINANCE OF THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY, AMENDING ARTICLE XVII, RESIDENT PERMIT PARKING, OF THE BOROUGH CODE TO CONSOLIDATE RESIDENT PARKING PERMIT REQUIREMENTS

Purpose: This Ordinance designates permit parking areas within Mendham Borough in which only resident vehicles or authorized visitor vehicles displaying valid permit parking decals may stand or be parkedduring specified hours. The Ordinance further sets forth the application process for the issuance of resident and visitor parking decals and establishes violations and penalties for non-compliance.

Mayor Serrano Glassner announced that a legal notice was published indicating that Ordinance #02-2021 was introduced and passed on first reading at the January 25, 2021 meeting and further indicated that the second reading and public hearing would be held on February 10, 2021 at 8:00 p.m. The public hearing was subsequently tabled to March 10, 2021 to allow further review and recommendation by the Council's Public Safety Committee.

The Borough Administrator further reported that a training session was recently held for employees to learn the Microsoft Teams platform.

Council Member Reilly inquired whether the Teams "chat" feature created any concerns regarding the Open Public Records Act (OPRA). The Borough Clerk responded that electronic records are subject to OPRA if sent or received by officials while conducting public business and are also subject to record retention.

Council President Badal reported that the final adjustments are being made to the anticipated 2021 budget due to changes made to the chart of accounts.

Council Member Andrew reported that the Recreation Committee is sponsoring a St. Patrick's Day DoorDecorating Contest and encouraged residents to participate. He further reported that the new tennis courts willbe opened in spring.

Board of Education

Council Member Andrew reported the Mendham Borough Board of Education introduced the 2021-2022 school budget and the West Morris Regional High School District Board of Education next meeting is scheduled for Monday, March 15th.

Public Safety [Standing Committee of the Council]

Council President Andrews reported that the First Aid Squad took possession of the new ambulance, EMS-3. A dedication and blessing ceremony is planned for March 17th. He thanked Police Chief Camoia for conducting an efficient interview process for the hiring of a new police officer to fill the recent vacancy and mentioned that a new police vehicle is expected to be delivered this month.

Lastly, Council President Andrews reported that the Route 525 road project is underway, and detours have been established during construction.

Public Works and Utilities [Standing Committee of the Council]

Council Member Kelly reported that DPW crews are doing pothole repairs. 15 tons of asphalt has been used.

Land Use [Standing Committee of the Council] and ECOSST Committee

Council Member Reilly reported that ECOSST's Scott Farm Workgroup will be discussing the use of the Scott Farm property and appurtenances.

MAYOR'S ITEMS

Mayor Serrano Glassner reported that the Borough has rolled out the Nixel platform and encouraged residents to sign up to Nixel on the Borough's website. She also reported that a community COVID-19 memorial ceremonyand tree planting is being planned for early spring as a remembrance to those loved ones who will be missed. More details concerning the memorial ceremony will be forthcoming.

Lastly, Mayor Serrano Glassner mentioned that the Borough's zoning officer had informed her that the high school inquired about the posting of lawn signs in front yards for each of the graduating class seniors. This matterwill be scheduled for Council discussion at a future meeting.
