OEM Storm Recap of Storm Riley 3-2-18 through 3-3-18 and Storm Quinn on 3-7-2018 — OEM Manager Nick Witczak provided an Impact and Actions written report to Mayor and Council and shared the weather conditions, the impact of each storm on the Borough and surrounding area, and the action taken by the OEM Manager, Borough department heads and Government administration and Police, Fire and First Aid. Discussion ensued and thank you were shared all around.

High School Safety Plan – Chief Camoia together with Chief Ross Johnson of Mendham Township reviewed the school safety plan. Chief Camoia shared that there are 2 part-time officers at the school until noon. They are following all the state requirements concerning fire drills, lockdowns and are looking into a "man trap" with partitions at the front door. They are also working with the Fire Department Chief Bruin to be more prepared for all school locations, business and governmental offices. Discussion ensued and updates will be forthcoming.

ADMINISTRATOR'S REPORT

Administrator Bushman reported that her Administrator's report was provided to the Mayor and Council in advance of the meeting. Mayor Henry asked for an update on the IT bid. Administrator Bushman replied that they were a bit behind because of the storms but it would be completed the following week before she left on vacation. The Mayor also asked about Scott Farms. Administrator Bushman noted that the monies have been awarded to the County and everything appears to be in place. Administrator Bushman shared that she would be meeting with the new Planner, Jessica

Caldwell on Monday 3/19/2018 to review open items, including preparation for the Green Acre grant round due in September/October. Councilwoman Glassner asked where things stood on guard rail install on Cherry Lane. Administrator Bushman reported that the County asked for us to install a guard rail. She would keep them advised of the progress of the project. Councilman Sharkey asked for an update on the tennis courts. He noted that he still wants to keep the tennis where the lights are. Discussion ensued about several options with no specific conclusion at this time. Administrator Bushman hearing no other questions concluded her report.

COUNCIL REPORTS, OLD & NEW BUSINESS

Public Works and Utilities Committee

Councilman Badal thanked Public Works Department for storm work and noted they are still picking up brush (173 piles so far). They worked over 180 man hours for plowing and salting. It was reported to him that they had some equipment breakdowns but all the repairs are complete. He shared that the Borough Sewer plant is anticipating that there is a problem with the flow and we may need to slip line the system (approximately 3 million for the entire system) but he suggested that the Council consider approval of using the camera to first identify the issues and the location of the problems. Discussion ensued regarding \$115,000 to camera the system vs \$3.5 million to slip line the system.

Mayor Henry made the motion to contract for the camera to CCTV the lines.

The Mayor asked that he arrange that with the Administrator and Councilman Badal concluded his report.

Personnel Committee and Local Economic Development Committee

Councilwoman Glassner reported that they were still working on the Marketing Brochure and the Business Survey and would keep them informed of the progress. Personnel Committee is finalizing the salary review and should be complete this week. She noted that she had nothing else to report and concluded her report.

Public Safety Committee

Councilman Andrews thanked the Department of Public Works and the OEM and Police, Fire and First Aid for all their efforts during the storms. He also shared that the "Emergency Services Experience" that was actioned off at the HSA fundraiser was purchased for \$700.00 and on that positive note he concluded his report.

Land Use Committee and Environmental Commission

Councilman Sharkey stated he had new on Planning Board but shared that the meeting of April 9th may be moved to accommodate the expected crowd if the Dunkin Donuts issue is on the agenda. He reported that he was unable to attend the Environmental meeting earlier that evening but he wanted to mention that there is a scheduled stream clean up and committee members will be participating. Councilman Sharkey stated that he had nothing else and concluded his report.

Recreation Committee

Councilman Witczak reported that the Recreation Camp Counselors was back on track and he believes it's due to the salary increase. He stated he had nothing else to report that evening.

Finance Committee

Council President Andrus was absent.

ATTORNEY ITEMS

Dawn Sullivan representing Dorsey/ Semrau stated that they had nothing to report this evening.

MAYOR'S ITEMS

Mayor Henry commented that the Mendham Apothecary is being sold to CVS and there has been some question as to the need to appear at Planning Board. He confirmed with Attorney Semrau that when there is no change is the use they are not required to come to Planning Board. Attorney Semrau confirmed that they are changing ownership and all based on what we know at this time he is entitled to sell for the same use with no appearance before the Board.

Mayor Henry reminded the Council of the agreement that was placed into service sometime back, after Hurricane Sandy, with the Sisters of Charity to provide shelter services. He noted that the construction of their new structure may no longer accommodate the shelter services going forward. He also stated that we won't know if we don't ask and he'd like to open that line of communication again to see if there are any services that are appropriate. Councilman Witczak stated that the warming centers appear to have taken the place of the shelter; but, he too thought it appropriate to revisit options with the Sisters of Charity. Mayor asked Administrator Bushman and Councilman Badal to look in to it. He concluded his report.

PUBLIC COMMENT

Mayor Henry opened the meeting to the public for comments.

Carol Brady, Mendham, NJ - She thanked all of the support staff for storm work and their attention to giving social media updates. She noted that the infrastructure was compromised and that created most of the issues. She also thought that JCP&L provided bad information and finally she would like to have access to a "friendly phone number" to report incidents for school safety without having to call 911. Chief Camoia asked that they call the Police Department directly.

Ron Weissman, Mendham, NJ – He noted that he would like to review his request for energy aggregation report updates. He provided the Mayor with correspondence. Mayor Henry commented that he has provided a copy to Administrator Bushman. He also noted that he would be meeting with Paul Ferriero to discuss stormwater compliance solutions and would request a written report be produced. He also asked to submit two articles to the Economic liaison, Councilwoman Glassner. Clerk Marlor offered to scan and distribute to the Mayor and Council.

Seeing no one else from the public wishing to be heard, Mayor Henry closed the public comment portion of the meeting.
