## April 14, 2021 MINUTES

## CALL TO ORDER

Mayor Christine Serrano Glassner called the April 14, 2021 Regular Meeting of the Mayor and Council to order at 7:00 p.m. in the Garabrant Center, 4 Wilson Street, Mendham, New Jersey and remotely by Zoom webinar, Meeting ID 841 1893 9092.

### MOMENT OF SILENCE AND FLAG SALUTE

Mayor Serrano Glassner led a moment of silence and proceeded with the Pledge of Allegiance.

### **MAYOR'S OPENING STATEMENT**

Mayor Serrano Glassner read the following statement:

Please take notice that the start time for regular meetings of the Mayor and Council of the Borough of Mendham shall begin at 7:00PM. Notice of this meeting of the Mayor and Council of the Borough of Mendham was published in the Daily Record and Star Ledger, posted in the Phoenix House, and was filed in the Office of the Borough Clerk in accordance with the Open Public Meetings Act. Official action will be taken at this meeting.

During a declared state of emergency when meetings of the Mayor and Council are held remotely, written comments to be read during the public hearings or public comment period listed on the agenda may be submitted in writing to our Borough Clerk electronically by email, or by letter, no later than 4:00PM on the date of the meeting. Only one public comment, whether oral or written, from each person at each public comment period will, as with all public comments, be heard or read. The reading of the written comments will, as with all public comments, be limited to four minutes and the reading will end after four minutes.

### **DISCUSSION ITEMS**

### Request from West Morris Regional High School regarding Student Graduation Lawn Signs

Mayor Serrano Glassner reported that in past years the Borough Council provided a temporary exemption of the Borough's sign ordinance to permit graduating seniors at the high school to place a lawn sign on their property during the month of June. She inquired whether the Borough Council wishes to approve a temporary exemption of the Borough's sign ordinance again this year.

The Borough Council voiced its concurrence to allow a temporary exemption of the sign ordinance, permitting graduating seniors at the high school, as well as at any of the Mendham Borough School District schools to place one or more lawn signs on their property.

## Motion

Council President Andrews made a motion to authorize a temporary exemption of the Borough's sign ordinance to permit graduating seniors at both West Morris Regional High School and graduating students attending a Mendham Borough School District school to place one or more lawn sign on their property during the month of June.

A voice vote was taken with all Council members present voting in favor. There were no abstentions.

The Borough Clerk will notify Mr. Schetelick, the Borough's zoning officer, of the Council's authorization.

## Request from St. Mark's Episcopal Church regarding proposed May 1<sup>st</sup> Boutique Event

Mayor Serrano Glassner informed the Borough Council that St. Mark's Episcopal Church is seeking permission to close a portion of the church parking lot on Saturday, May 1<sup>st</sup> to hold a vendor fair "Boutique Event" in advance of Mother's Day and inquired if the Borough Council had any concerns.

The Borough Council provided its support for the event. The Borough Clerk was asked to notify the sponsor to submit a Special Event Application for Council consideration at its next meeting.

## Adopted New Jersey Cannabis Legislation

Mr. Semrau provided an update of the adopted state legislation concerning recreational cannabis. Six types of licenses will be available, five of which may be legislated by local government. A sixth license, the "cannabis delivery license" cannot be restricted by a municipality due to intra-state commerce law.

Licenses that the Borough Can Permit or Prohibit

- 1) Cannabis Cultivator License (facilities that grow and cultivate);
- 2) Cannabis Manufacturer License (for facilities that manufacture, prepare, and package cannabis);
- 3) Cannabis Wholesaler License (facilities that obtain and sell cannabis items for later resale by other licensees);
- 4) Cannabis Distributor License, (businesses that transport bulk cannabis plants from one cultivator to another or any other cannabis items in bulk from licensed businesses to other licensed businesses);
- 5) Cannabis Retailer License (storefronts that sell directly to consumers); and
- 6) Cannabis Delivery License

Mr. Semrau advised that the state legislation provides municipalities 180 days, until August 21, 2021, to enact ordinances opting out of, or selectively permitting, certain licenses. If the Borough intends to opt out of certain, newly-legal activity (e.g. cultivation, retail sales), it must do so by August 21, 2021, or its next opportunity to do so will come in 2026.

If the Borough does not enact an ordinance by August 21, 2021 prohibiting operation, it will automatically lose the ability to restrict cultivation and wholesale sales in industrial zones and retail sales in business/commercial zones. If the Borough enacts ordinances to allow the above types of uses, it can limit the number and types of business licenses, as well as restrict the time, location, & manner of operations.

It was further reported that police departments will have several legal and enforcement considerations, including protocols for dealing with underage persons and traffic stops. Mr. Semrau confirmed that his office will be discussing these issues with Chief Camoia and will be working with him as the State guidance on the issues becomes clearer. Mr. Semrau also advised that the New Jersey League of Municipalities has recommended municipalities to opt-out until state regulations are in effect.

In closing, Mr. Semrau advised that by the end of the month of June the Borough Council must decide what options to move with:

- 1. Fully prohibit the sale of cannabis for recreational use available by law (this will not prohibit personal recreational use within the Borough);
- 2. Fully permit licensing and sale of recreational cannabis as permitted by law, or with local restrictions; or
- 3. Take a hybrid approach by permitting certain licenses (e.g., cultivation) but precluding others (e.g., retail sales).

### #05-2021 ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, TO AMEND CHAPTER 60, AFFORDABLE HOUSING, REGARDING ADMINISTRATIVE AGENT FEES

Purpose: This Ordinance amends Chapter 60, Affordable Housing, of the Borough Code by authorizing the Borough to hire an administrative agent to administer affordable units in Mendham Borough and sets forth that administration costs shall be reimbursed to the Borough. Administration costs will include affirmative marketing, determining, and establishing rents and sales prices for affordable units, establishing buyer and tenant income eligibility, certifying buyer's income eligibility to purchase an affordable unit, and rental and re-sale of units.

## #06-2021 AN ORDINANCE OF THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY, AUTHORIZING THE ACCEPTANCE OF AN EASEMENT IN FAVOR OF THE BOROUGH OF MENDHAM FOR A PORTION OF THE PROPERTY KNOWN AS BLOCK 1901, LOT 19

Purpose: This Ordinance provides a 10-foot-wide walking path easement on a portion of private property known as Block 1901, Lot 19 for the pedestrian benefit of the public, which will address the long-standing need to memorialize the public's pedestrian need to access Main Street in Mendham. The easement is limited to pedestrian use, no motorized vehicles, and from dawn to dusk for a term of one year.

- Purpose: This Ordinance appropriates \$1,017,000 from moneys available in the Capital Improvement Fund of the Borough for capital improvements of (a) the Department of Public Works facilities, including rehabilitation of the Administrative/Mechanical/Garage building, the demolition of the Equipment/Vehicle storage building and the construction of a new building (\$630,000); (b) the improvement of various roads in the Borough (\$317,000); (c) the improvement of the Garabrant Center by the construction and installation of a dais (\$25,000); and (d) the acquisition and installation of new and additional equipment for use by the Police Department of the Borough including an in-car body camera system.

### **Board of Health**

Council President Andrews reported that Atlantic Health ran a vaccination clinic at MASH last month and mentioned that Bernards Township Department of Health hired a new outreach coordinator.

## Recreation and Parks [Standing Committee of the Council]

Council Member Andrew reported new tennis courts opened April 10<sup>th</sup> and confirmed that the Recreation Committee has scheduled a series of concerts and movies in the park for the summer months. He also reported that a Memorial Day ceremony is being planned, as well as Labor Day festivities.

#### Public Safety [Standing Committee of the Council]

Council President Andrews reported that the Mendham Borough Police Department will be hosting its first annual "Fishing Frenzy" on Sunday, May 9<sup>th</sup> from 10:00am to 1:00pm at the Mountain Valley Park, rain, or shine. The event is open to children under 16 years of age. He also reported that the new ambulance, EMS-3, is out of service due to a Stryker Auto Lift stretcher issue.

Council President further reported that the Hometown Heroes Banner Program committee is making its final decision for May's honorees. The program recently secured a \$400.00 donation from the Mendham Business Association for the purchase of banners. Anyone interested in donating to the program can do so by contacting Council President Andrews. He also reported that Memorial Day flags on Veterans Graves will take place on Sunday, May 23<sup>rd</sup> at10:00 am. Ryan Takayama's Eagle Project identified, mapped, and raised funds to place a veteran flag medallion on each veteran's final resting place so that no veteran would be forgotten.

Lastly, Council President reported that a Memorial Day Ceremony is being planned for Monday, May 31<sup>st</sup> at 10:00am at the corner of Park and Mountain.
