# RESOLUTION OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, OPPOSING DEPARTMENT OF AGRICULTURE BEEKEEPING REGULATIONS

WHEREAS, the New Jersey Department of Agriculture has published new beekeeping regulations in the New Jersey Register which implement widespread revisions to the existing beekeeping laws; and

WHEREAS, at a time when municipalities and their citizens are trying to protect beekeeping, the proposed regulations reveal that the Department of Agriculture is working against the act of beekeeping; and

WHEREAS, the proposed regulations that restrict bee colony density by prohibiting new hives on residential lots of less than one-quarter of an acre, and placing a two-hive limit on one-quarter to five-acre residential lots, are the ones most opposed by local beekeepers; and

WHEREAS, the regulations also restrict hive location in that all hives must be located a minimum of 10 feet from any property line and at least 25 feet from any roadside, sidewalk, or path and 85 feet away from any public place, including playgrounds, sports fields, schools, or churches, unless permission is granted for educational or research purposes; and

WHEREAS, the regulations require beekeepers to build a flyway barrier at least six feet in height consisting of a solid wall, fence, dense vegetation, or combination thereof that is located parallel to the property line and extending 10 feet beyond the colony in each direction; and

WHEREAS, the regulations require beekeepers to provide all hives with access to "adequate sources of water" defined as a water source that can never be dry; that supplies at least one gallon per day per colony; and that is located no more than 25 feet from the hives and on the same property as the hives; and

WHEREAS, the hive limitations and other proposals, such as the requirement of a six-foot high barrier around hives that are too close to neighbors' properties and mandated participation in continuing education courses, may be the result of an overreaction by the Department of Agriculture to one bad beekeeper; and

WHEREAS, these new regulations ignore key best management practices for beekeeping and would be difficult for the vast majority of New Jersey municipalities to enforce; and

WHEREAS, if these new regulations are adopted, beekeepers in the Borough of Mendham will immediately be in violation of the new regulations; and

WHEREAS, the Borough agrees with the President of the New Jersey Beekeepers Association, who does not recommend the adoption of the proposed regulations for the following reasons: (1) the rationale behind these rules is poorly supported and seems to be based more on fear than on fact; (2) the proposed regulations create distinct problems and contain redundancies that are problematic; (3) the proposed rules will be difficult to fairly enforce and are largely inconsistent with honey bee biology; and (4) the proposed regulations will likely cause more harm than good to New Jersey's citizens.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Mendham, County of Morris, State of New Jersey, that the Borough wishes to go on record with the New Jersey Department of Agriculture that the Borough is opposed to the new beekeeping regulations which would have a detrimental effect on beekeeping in the Borough as well as throughout New Jersey, and the Borough urges the New Jersey State League of Municipalities to work toward creating legislation with straightforward regulations based on fact,

science, and best management beekeeping practices that will protect both beekeepers and non-beekeepers within the State of New Jersey; and

#### **ORDINANCE 03-2018**

# AN ORDINANCE OF THE BOROUGH OF MENDHAM TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the governing body of the Borough of Mendham in the County of Morris finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the governing body hereby determines that a 1.0% increase in the budget for said year, amounting to \$61,470.54 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the governing body hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the governing body of the Borough of Mendham, in the County of Morris, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2018 budget year, the final appropriations of the Borough of Mendham shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$215,146.88, and that the CY 2018 municipal budget for the Borough of Mendham be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED,** that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
