Discussion of Item 2., Public Project Proposals.

Mayor Serrano-Glassner recognized Mr. Mark Tosso, the applicant and Youth Minister for St. Joseph's Church, who was in attendance via video conferencing.

Mr. Tosso informed the governing body that each year St. Joseph's Church hosts an Appalachian Outreach mission to help the working-poor in eastern Kentucky with home repairs. He mentioned that the mission has been cancelled this year due to the COVID-19 outbreak and because of this St. Joseph's Church has proposed several service projects in Mendham Borough. Mr. Tosso further mentioned that the work groups would consist of students and adult chaperones. Everyone would follow COVID-19 protocols (daily temperature checks, wearing face masks and following social distancing mandates). Local businesses would be patronized to provide lunch, drinks and snacks to the volunteers.

Council President Badal, Finance Committee chair, reminded everyone that funding was not appropriated in the 2020 budget for any of the proposed projects; however, he mentioned that after he and the Borough Administrator examined the budget, approximately \$7,500 may be available to be used towards the service projects.

Council Member Reilly reported that the ECOSST working group recommended appropriating Open Space funds for the purchase of materials and supplies for these service projects.

Mayor Serrano-Glassner led discussion on each of the nine proposed service projects.

- a) Phoenix House Garden Fence Repair: The Council provided approval for this service project.
- b) Mountain Valley Park, Information Kiosk: The Council determined that the existing kiosk should not be replaced but only repaired.
- c) Mountain Valley Park, Fireplace: Due to the excessive cost of the project, the Council did not provide consent for this proposed service project.
- d) India Brook Park, Information Kiosk: New kiosk with a built-in bench and lean-to roof. The Council determined that the Borough's construction official should review this proposal and make a recommendation to the Council.
- e) Scott Farm, Fence along Mountainside Road: The proposed project was removed subject to the Borough Administrator checking with the grant consultant on the fence structure and installation method that should be followed.
- f) Scott Farm, Restore Chicken Coops: The Council provided approval to repair the structure.
- g) Scott Farm, Rain Garden: The Council inquired about the future maintenance of the rain garden and sought further information on its practical application to improve storm water run-off and drainage on the site.
- h) Scott Farm, Structure Drainage Improvements: This project would require extensive trenching to improve drainage on the site. Public works would mark out the location of the trench.
- i) Scott Farm, Repairs to Secondary Structure: The Council provided approval to replace the trim work that is deteriorating.

The governing body requested that the Borough Administrator meet with Mr. Tosso to further vet the viability of the proposed projects and to determine the estimated cost and availability of funding.

#07-2020 AN ORDINANCE OF THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING THE BOROUGH CODE TO PROVIDE FOR THE COLLECTION OF DEVELOPMENT FEES IN SUPPORT OF AFFORDABLE HOUSING AS PERMITTED BY THE NEW JERSEY FAIR HOUSING ACT Mayor Serrano-Glassner announced that the Public Hearing for this Ordinance is scheduled for July 15, 2020.

Mr. Semrau advised that the state imposes a developer's fee of 1.5% of the assessed value for all new residential development and in cases where an additional dwelling unit is added to an existing residential structure. A "bonus" development fee of 6.0% of the assessed value would be imposed for each unit that may be constructed pursuant to a "d" variance under the Municipal Land Use Law. For new commercial construction on an unimproved lot(s), a developer's fee of 2.5% of the assessed value of the land and improvements would be imposed. Mr. Semrau further advised that fees collected pursuant to this Ordinance are deposited in the Borough's Affordable Housing Trust Fund and would be used for the sole purpose of providing very low, low- and moderate-income housing in accordance with a Court-approved Spending Plan.

Mr. Semrau advised that the Borough's administration has had several meetings with the applicant, Six Main Street, LLC, to discuss a balanced shared use of ten overnight parking permits in the municipal lot (Block 601, Lot 16). The ten overnight parking permits, he mentioned, are instrumental to the approval of the application pending before the Board of Adjustment and further mentioned that the overnight parking permits would not infringe on public parking in that lot.

Council President Badal questioned who would pay for the on-going maintenance and lighting costs, among other things, associated with the ten overnight parking spaces.

Mr. Semrau confirmed that a follow up agreement between the parties would set forth the terms and conditions concerning improvements and on-going maintenance costs associated with the ten parking spaces, as well as parking revenues that may be payable to the Borough.

Mayor Serrano-Glassner confirmed that the Board of Adjustment's approval of the Six Main Street, LLC's application is conditioned upon the applicant receiving approval from the Borough Council for the ten overnight parking spaces. She noted that the project would bring much needed rehabilitation to an aging property and vitality to Mendham's Main Street.

Mr. Semrau advised that on June 3<sup>rd</sup>, Governor Murphy issued Executive Order 150, which allows outdoor dining at food or beverage establishments effective June 15<sup>th</sup>. Establishments would be required to follow COVID-19 health and safety protocols issued by the New Jersey Department of Health. Further, he advised that the Director of the Division of Alcoholic Beverage Control issued an Order that would allow a licensed establishment to temporarily expand the licensed premises in order to permit retail alcoholic beverage sales and service at the outdoor areas by applying for a Temporary COVID19 Expansion Permit. The Temporary COVID19 Expansion Permit would be subject to the approval of the municipality (issuing authority). Mr. Semrau further advised that this resolution temporarily authorizes the Borough Administrator to consult with the Municipal Clerk, Chief of Police and Health Officer, and then, if all agree, approve endorsement of the issuance of a Temporary COVID19 Expansion Permit on behalf of the governing body.

# ADMINISTRATOR'S REPORT

Ms. Bushman reported that representatives from Morris County Planning and Preservation will be conducting video conferencing site visit of the Phoenix House and the Scott Farm barn on June 13<sup>th</sup> as part of the grant application process. She further confirmed that the consultant, Connolly & Hickey, submitted a grant application with the New Jersey Historic Trust for the Phoenix House. Belgium block curbing will be installed along Hilltop Road by the county and will delay paving by seven days. Lastly, Ms. Bushman reported that the New Jersey I-Bank has postponed loans due to public agency credit concerns due to the COVID-19 state of emergency. Bond counsel resubmitted Mendham Borough's documentation and the loan is scheduled to close in early July.

Council Member Andrew inquired about the status of the construction of the tennis courts and was informed that construction continues. Drainage work is completed.

Council Member Andrews reported that the police department installed the new "Your Speed Is" sign at New Street and confirmed that "Your Speed Is" signage installed along Dean Road continues to track vehicle traffic counts and speed and is monitored by the police department. He further reported that paving of Talmage Road has been completed with some minor cleanup work to be performed by the contractor. Lastly, Council Member Andrews reported that the Mendham First Aid Squad will be present at the high school graduation on June 9<sup>th</sup> and confirmed that the purchase of the Police Chief's vehicle and one police patrol vehicle remains pending from last year.

Mayor Serrano-Glassner reported that she is working with the West Morris Mendham High School administration concerning Student Graduating Class of 2020 signage proposed along Main Street. She also mentioned that the Mendham Borough homepage will be revamped shortly with new content. Lastly, she thanked the Borough Council and workforce for their efforts in assisting residents, particularly residents at the Mendham Area Senior Housing during the COVID-19 shut down.

Melissa Rawley-Payne, 23 Drake Road, expressed her support for LGBTQ and Black Lives Matters equality and recommended establishing a civilian police oversight group.
