Ms. Bushman provided her written Administrator's Report dated June 22, 2020 to the governing body.

Council Member Reilly inquired about the status of the 6 E. Main Street application presented to the Historic Preservation Commission. Ms. Bushman responded that the Historic Preservation Commission tabled the application with no rescheduled date.

COUNCIL COMMITTEE REPORTS

Finance [Standing Committee of the Council]

Council President Badal reported that tax collections have been good and had nothing new to report.

Board of Health

Council Member Andrew reported that the Board of Health met on June 3rd and had nothing new to report.

Recreation and Parks [Standing Committee of the Council]

Council Member Andrew reported that the first movie for the 2020 Summer Movie Series will feature "The Incredibles" on July 1st at Borough Park and further reported that on June 28th at 6:30 p.m. the first Concert in the Park will be held at the Borough Park gazebo. He also reported that construction of the Botti Pavilion and the tennis courts are on schedule.

Board of Education

Council Member Andrew reported that the Mountainview Middle School held its virtual promotion ceremony for 8th graders and reported that the West Morris Regional School District Board of Education is holding its regular business meeting tonight.

Public Safety [Standing Committee of the Council]

Council Member Andrews addressed public comments received at the June 10th Council meeting concerning policing matters in Mendham Borough. With respect to a resident's allegation that was made referencing an African-American resident who had been stopped multiple times by the Mendham Borough Police, Council Member Andrews reported that police department records confirm that only one traffic stop was made for a latenight speeding incident and a warning was issued at that time. Council Member Andrews also corrected another citizen's allegation that the Mendham Borough Police Department continues to post arrests made by its officers on the department's Facebook page. He confirmed that no Facebook posts regarding arrests have been posted since July 2019.

Council Member Andrews reported that Charlie Lucke, a former Mendham Borough police officer passed away on June 17th and provided his condolences to the family. He further reported that the Public Safety Committee meet earlier in the day with Chief Camoia. The committee agreed to explore the procurement of body worn cameras for all police officers and would report back with more information and coordinate with the Finance Committee on pricing on impacts on the budget. Council Member Andrews also reported that the police department continues to monitor vehicle speed along New Street, while work continues on the Hilltop Road milling and repaving project and confirmed that the average vehicle speed is 20 MPH and the 85th percentile is 24 MPH.

Personnel [Standing Committee of the Council]

Council Member Martin reported that interviews for the tax collector position will be scheduled next week.

Public Works and Utilities [Standing Committee of the Council]

Council Member Kelly reported that public work crews have been busy with milling and paving road projects and further reported that a new concrete pad and some upgraded drainage have been installed at doorway to the Garabrant Center and that Montana Construction completed the milling and paving of the Garabrant Center parking lot. He also reported that a new landscape bed and plantings have been installed at the Firehouse flagpole and that public work crews have re-seeded the grass strip between the new curbing and the sidewalk along Hilltop Road.

Council Member Reilly had nothing new to report.
