**RESOLUTION PROVIDING FOR EMERGENCY TEMPORARY  
APPROPRIATIONS FOR THE 2025 TEMPORARY CURRENT FUND BUDGET**

**WHEREAS**, the official budget for calendar year 2025 will be adopted on April 09, 2025 and provisions need to be made for the 2025 Temporary Current Budget appropriations for expenditures between March 24<sup>th</sup> and April 9<sup>th</sup> and N.J.S.A. 40A: 4-20 provides for the creation of an emergency temporary appropriation for the purposes herein; and

**WHEREAS**, the adopted 2025 Temporary Current Fund Budget amount is \$2,166,420.00 and the emergency appropriation is \$40,600.00; and

**WHEREAS**, the amended 2025 Temporary Current Fund Budget total is \$2,207,020.00;  
and

**WHEREAS**, the emergency temporary appropriations by account are as follows; and

**BE IT FURTHER RESOLVED**, that all other Borough officials and employees are hereby authorized to take all action necessary and appropriate to effectuate the terms of this Resolution.

This resolution shall take effect immediately.
