## October 13, 2021 MINUTES

#### **CALL TO ORDER**

Mayor Christine Serrano Glassner called the October 13, 2021, Regular Meeting of the Mayor and Council to order at 7:00 p.m. in the Garabrant Center, 4 Wilson Street, Mendham, New Jersey.

#### **MOMENT OF SILENCE AND FLAG SALUTE**

Mayor Serrano Glassner led a moment of silence and proceeded with the Pledge of Allegiance.

#### ORDINANCE FOR INTRODUCTION

#15-2021 ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 102, FEES, § 102.1, SCHEDULE OF FEES, TO INCORPORATE OUTDOOR DINING PERMIT FEES

Purpose: Chapter 102, Fees, of the Borough Code will be amended to reflect the new outdoor dining permit fees.

Public hearing scheduled for October 25, 2021.

Mayor Serrano Glassner reported that the ordinance would allow restaurants to expand their businesses (in some cases up to 20%) with outdoor seating. Permit fees associated with the expansion of outdoor dining would cover the Borough's administrative and inspection costs.

Ordinance #15-2021 was opened for Council discussion.

Council Members Andrew and Martin were not in favor of including permit fees for outdoor dining and voiced their opposition to imposing any permit fee.

Council President Andrews and Council Members Kelly and Badal were in favor of including *de minimus* permit fees for outdoor dining in order to cover the Borough's administrative and inspection costs and agreed that taxpayers should be paying for user-based permitting costs.

Upon discussion, the Council concurred that the initial permit fee schedule would remain as stated; however, in circumstances where there would be no change in either ownership or seating capacity upon renewal of the establishment's outdoor dining permit, the renewal permit fee would be reduced to 25% of the initial permit fee.

Mr. Semrau further advised that the Council can always waive fees if and when it may be appropriate to do so.

Council President Andrew made a motion to approve Ordinance #15-2021 on introduction with an amendment adding that in circumstances where there would be no change in either ownership or seating capacity upon renewal of the establishment's outdoor dining permit, the renewal permit fee would be reduced to 25% of the initial permit fee.

# #13-2021 ORDINANCE OF THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE TO PERMIT OUTDOOR DINING AND OUTDOOR SEATING TO FACILITATE SMALL BUSINESS RECOVERY NEEDED IN LIGHT OF THE COVID-19 PUBLIC HEALTH EMERGENCY

Purpose: Recent changes in the economy, including a public health emergency and resulting social distancing requirements, have led the Borough's Finance Committee to review outdoor dining requirements. The Governing Body desires to enable local restaurants and food and beverage service establishments, with appropriate guidelines, to serve customers and encourage social distancing requirements. Outdoor dining and outdoor seating can accommodate the Borough's long-term Master Plan vision of protecting the small-town character of the community, while also helping to maintain a healthy business district.

Legal Notice Statement: A legal notice was published indicating that Ordinance #13-2021 was introduced and passed on first reading at the September 9, 2021 meeting and further indicated that the second reading and public hearing would be held on October 13, 2021 at 7:00 p.m. Copies of this Ordinance were made available to the public and posted in accordance with the law.

Council Member Badal mentioned the red-line version of changes made by Mr. Semrau's office to Ordinance #13-2021 had not been received. He requested the ordinance be tabled to the next meeting.

#### **ADMINISTRATOR'S REPORT**

A copy of the Administrator's Report dated October 13, 2021 was distributed to the Governing Body. The administrator further reported that Peter Henry, the Borough's Joint Land Use Board attorney, will be retiring at the end of the year and also reminded the governing body that the Mendham Business Association Gold Outing will be held on October 18<sup>th</sup>.

#### **COUNCIL COMMITTEE REPORTS**

#### Finance [Standing Committee of the Council]

Council Member Badal provided a summary of budget revenues versus expenditures. He requested that the administrator provide the Finance Committee with a report on grant revenues received for the year. The Finance Committee will be meeting later in the month to begin the 2022 operating and capital budget requests.

#### **Board of Health**

Council President Andrews had nothing new to report.

#### **Recreation and Parks [Standing Committee of the Council]**

Council Member Andrew reported that the Food Truck Festival held on Saturday, October 2<sup>nd</sup> was well-attended and reminded everyone that a Halloween movie night will be held at the Garabrant Center on Saturday, October 30<sup>th</sup>.

#### **Board of Education**

Council Member Andrew requested that a letter be sent to the Mendham Borough Board of Education congratulating them on be rated by *Niche* as "One of the safest School Districts in New Jersey."

#### **Public Safety [Standing Committee of the Council]**

Council President Andrews reported that six additional Hometown Heroes banners have been approved. Veterans include WWII veterans Tim Pierson, William "Bill" Fleming, and Jack O'Keefe; Korean War veterans Neil Henry and Bobby Hall; and, Cold War veteran Jim Cillo (Past Chief of Police, Past Councilman, Past Captain, and current active member of the Mendham First Aid squad). Banners will be displayed in the beginning of November through Veterans Day. He further reported that the Pastime Club will have a Veterans Day Celebration on November 11<sup>th</sup>.

Council President Andrews thanked the police chief and administrator for their work on renewing a shared services agreement with Washington Township for Municipal Court services. The agreement, which is under attorney review, reflects approximately a \$3,500 reduction in costs over the 4-year agreement period.

He also reported on traffic concerns at the main high school entrance. To ease traffic congestion on to Main Street, Chief Camoia has arranged to extend the time the side gate on Drake Road until 6:00pm. Currently, the gate is closed at 3:00pm.

Lastly, Council President Andrews reported that police body worn cameras have been purchased and administrative training has been completed. Full implementation by the police department is anticipated by December.

#### **Personnel [Standing Committee of the Council]**

Council Member Martin reported Mendham Borough is currently interviewing candidates for the DPW position.

#### **Public Works and Utilities [Standing Committee of the Council]**

Council Member Kelly reported that the Elkin property has been cleaned up and further reported that some minor landscaping improvements have been made to the Garabrant Center property. He also reported that the demolition of the DPW garage has been completed and briefly reported on the open house information session recently held for the county's Cherry Lane bridge replacement project.

#### Land Use [Standing Committee of the Council] and ECOSST Committee

Council Member Reilly was absent.

#### **ATTORNEY'S ITEMS**

Mr. Semrau had nothing new to report.

#### **MAYOR'S ITEMS**

Mayor Serrano Glassner reported that the owner of the Dunkin Donuts will be improving the fencing and site conditions.

#### **PUBLIC COMMENT – AUDIENCE PARTICIPATION**

Mayor Christine Serrano Glassner opened the public comment portion of the meeting.

Seeing and hearing no one wishing to speak, Mayor Serrano Glassner closed the public comment portion of the meeting.

#### **APPROVAL OF VOUCHERS**

Bills List dated October 13, 2021. The Bills List had been posted on the website for full disclosure to the public.

The Council did not act on the approval of vouchers.
