### **PRESENTATIONS**

### Mendham Borough Police Department Certificate of Re-Accreditation

Police Chief John Camoia presented the Mendham Borough Police Department's Certificate of Re-Accreditation to Mayor Serrano Glassner. The re-accreditation is awarded by the New Jersey State Association of Chiefs of Police confirms that the police department follows best practices in law enforcement.

Mayor Serrano Glassner accepted the framed Certificate of Re-Accreditation and congratulated Chief Camoia and all polices officers and thanked the police department for their service to the community and excellent work in law enforcement.

The Borough Council and all in attendance congratulated Chief Camoia and the police department.

### **Sisters of Christian Charity**

Mr. Edward Buzak, Esq. (attorney for the Sisters of Christian Charity religious order), Mr. Tom Malman and Mr. Jason Boggard (representing Accordia Realty), and Sister Ann (Sisters of Christian Charity religious order) gave a summary presentation of a proposal to rehabilitate and re-purpose the Sisters of Christian Charity's Mother House (350 Bernardsville Road) into 94 luxury residential market unit apartments. The proposal includes a 20-acre subdivision of the 112.9-acre property for a below grade parking deck that would accommodate up to 200 spaces, main entry driveway improvements to the Mother House, and signage. Minimal changes would be made to the historic exterior The Mother House building.

Purpose: Recent changes in the economy, including a public health emergency and resulting social distancing requirements, have led the Borough's Finance Committee to review outdoor dining requirements. The Governing Body desires to enable local restaurants and food and beverage service establishments, with appropriate guidelines, to serve customers and encourage social distancing requirements. Outdoor dining and outdoor seating can accommodate the Borough's long-term Master Plan vision of protecting the small-town character of the community, while also helping to maintain a healthy business district.

Legal Notice Statement: A legal notice was published indicating that Ordinance #13-2021 was introduced and passed on first reading at the September 9, 2021 meeting and further indicated that the second reading and public hearing would be held on October 13, 2021 at 7:00 p.m. At the October 13, 2021 meeting, Ordinance #13-2021 was tabled and the public hearing re-noticed to October 25 2021. Copies of this Ordinance were made available to the public and posted in accordance with the law.

### **ADMINISTRATOR'S REPORT**

A copy of the Administrator's Report dated October 25, 2021 was distributed to the Governing Body. The administrator further reported that the Mendham Business Association's Holly Trail will take place on December 4<sup>th</sup> and further mentioned that customers enrolled in the Mendham Area Energy Cooperative (MAEC) program will automatically roll back to JCP&L as the electricity provider when the MAEC program ends.

Council Member Badal sought confirmation on whether the Borough could recoup any of its repair costs concerning failure of the design and installation of Chestnut Glen subdivision drainage system under the errors & omissions insurance policy provided for the Engineer who signed-off on the design and build-out of that drainage system.

Mr. Semrau advised that once the Borough approved the development it inherited an obligation to maintain the storm drain system and roadways.

### **Finance [Standing Committee of the Council]**

Council Member Badal reported that the Finance Committee would be meeting on October 25<sup>th</sup> to begin discussions on the 2022 operating and capital budgets.

### **Recreation and Parks [Standing Committee of the Council]**

Council Member Andrew reported that a Halloween movie night will be held at the Garabrant Center on Saturday, October 30<sup>th</sup> and that the Pastime Club will be hosting a Veterans Day ceremony on November 11<sup>th</sup>.

### **Board of Education**

Council Member Andrew reported that he would be presenting a commendation award to the Mendham Borough Board of Education on behalf of the Mayor and Council recognizing the School District's A+ ranking by *Niche* and for being named as the safest school district in Morris County.

### **Public Safety [Standing Committee of the Council]**

Council President Andrews congratulated Chief Camoia and the police department on its Re-accreditation by the New Jersey State Association of Police Chiefs.

### **Personnel [Standing Committee of the Council]**

Council Member Martin reported that an authorizing resolution to hire a candidate for the DPW position would be on the next Council agenda. She also reported that the Personnel Committee will be reviewing the Personnel Manual and employee salaries for the 2022 calendar year and further informed the Council of Karen Orgera's resignation.

### **Public Works and Utilities [Standing Committee of the Council]**

Council Member Kelly reported that the construction of the DPW garage is on schedule and also reported that the new basketball backboards have been installed at the park.

### Land Use [Standing Committee of the Council] and ECOSST Committee

Council Member Reilly reported on a recent resignation on the ECOSST Committee.

Mr. Semrau advised that his office would be finalizing the Borough's closing transaction concerning the acquisition of the United Methodist Church's open space parcel.
