Municipal Excess Liability Joint Insurance Fund Risk Management Compliance

Dear Mayor Henry and Council:

At the most recent Council meeting, questions arose concerning a Resolution to amend the Borough's Policy and Procedure Manual that would bring the Manual into compliance with the Best Practices prescribed by the Municipal Excess Liability Joint Insurance Fund (JIF). As you are aware, the JIF requires that in order to obtain a favorable deductible, the Borough must comply with JIF Best Practices. And in order to continue to comply, the Borough must pass a Resolution making four amendments to its Policy and Procedure Manual.

The questions that arose regarding this Resolution mainly concern Subpart #4, which states that: "Employees not exempt from the Federal Fair Labor Standards Act will receive overtime compensation for hours worked in excess of forty in a weekly period at the rate of one and one-half times the regular rate of pay. Employees may choose overtime compensation in the form of overtime pay or compensating time off."

Council members expressed concern about how significantly the above provision would impact the Borough's payroll. For purposes of clarification, it should be noted that the current income threshold for exemption to Fair Labor Standards Act's (FLSA) minimum wage and overtime pay protections is \$455 per week. This means, effectively, that any employee of Mendham Borough earning more than \$23,660 annually is not entitled to protection under the FLSA. It is only those employees making less than this amount, approximately \$11.38 in a 40-hour-per-week job, who would be entitled to FLSA protection and who, accordingly, would be entitled to overtime compensation for time worked beyond 40 hours per week. Hopefully this addresses the Council's concerns.
