Dear Mayor Henry and Members of the Council, I wanted to take this opportunity to thank Mayor Henry, Councilman Andrus and Councilman Witczak for their years of service to the Borough.

With respect to Mayor Henry, you have given countless hours to the Borough for your service. Often you would go in early and have meetings with the Administration or on Saturday mornings and take numerous calls in the evening. That is in addition to serving as a member of the Planning Board and making yourself available at any point in time with respect to issues in the community. It became customary practice to speak to Mayor Henry on the weekends especially prior to a Council meeting so that he was certain to be prepared for the meeting and address all issues.

Over the years I saw Mayor Henry in a very humble way exemplify leadership and gain a consensus of the Governing Body when there were legislative or policy issues for consideration and discussion. Throughout his term as Mayor there were differences of opinion but never a divide between the Mayor, Administration and the Governing Body. Now I have heard that Mayor Henry sometimes loses his cool, but that's only on a phone call with Borough Attorney! But I never heard him speak about anything less than the best interest of the residents of the Borough.

During the Mayor's tenure the Borough was named by New Jersey Magazine as the number one municipality in the State of New Jersey.

I just wanted to say thank you to Mayor Henry for the opportunity to work for you and your Administration and of course the Council. I also wanted to express thanks and appreciation to the dedication and patience of his wife Leslie as their family continues to grow with grandchildren and Neil being able to balance and maintain his friendships, his family, his professional career and his commitment to Mendham.

Few can say that they left office and also worked hard and stepped aside on their own timetable. Moreover, it is such a rarity nowadays for someone to achieve all of this and at the same time take a lifelong friend and resident in Chris Glasser and wholeheartedly support her efforts to become Mayor.

#### [Verbatim transcript]

Marlor: I actually think this is a Public Session and I...

Sullivan: It is a public session, but it's a matter that is potentially litigation and its personnel; it's disciplinary.

Marlor: Would you like to read what my statement is because it's really...

Mayor Henry: No, we're going, were going to make this...

Marlor: I just really, really, really...

Mayor Henry: We're going to make this very simple, okay.

Marlor: Yeah.

Mayor Henry: The matter is closed. Thank you very much.

Mayor Henry opened public comment for any members of the public wishing to be heard.

Police Chief Camoia on behalf of the Mendham Borough Police Department, thanked Mayor Henry, Council President Andrus and Councilman Witczak for their years of his service to the town and presented each of them with a commemorative Challenge Coin from the Police Department.

Bruce DiBisceglie, Mendham Borough Recreation Director, congratulated Mayor Henry, Council President Andrus and Councilman Witczak for their years of his service and support over the years in furthering community events and civic pride.

Seeing no one else wishing to be heard, Mayor Henry closed the public comment session.
