- **BE IT FURTHER RESOLVED** that the approval of the sanitary sewer connection application is based upon the representations made by the applicant as well as the information contained in the sanitary sewer connection application; and
- **BE IT FURTHER RESOLVED** that the approval is conditioned upon all plumbing on the premises to comply with all existing provisions of the Plumbing Code.
- **BE IT FURTHER RESOLVED** that prior to any occupancy of the facility for the proposed use, the applicant must contact the Borough Plumbing Official to schedule an inspection to verify that the compliant fixtures are in place; and
- **BE IT FURTHER RESOLVED** that this shall not constitute an endorsement or approval with respect to the pending Planning Board application.

This Resolution shall take effect immediately, but the approval hereby granted shall be subject to revocation if the flow standard as projected is exceeded in actual use or if the Applicant were to violate the applicable sections of the Borough Code.

ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, TO AMEND CHAPTER 15, ENVIRONMENTAL COMMISSION, TO INCOPORATE FUNCTIONS OF THE OPEN SPACE, RECREATION AND FARMLAND AND HISTORIC PRESERVATION COMMITTEE

WHEREAS, in 2017, the Borough of Mendham amended Chapter 15, Environmental Commission, to incorporate functions of the Shade Tree Advisory Committee by way of Ordinance No. 7-17 adopted on August 17, 2017; and

WHEREAS, the Borough of Mendham has determined that it is in the best interest of the Borough to amend Chapter 15 to also incorporate functions of the Open Space, Recreation and Farmland and Historical Preservation Committee; and

WHEREAS, the Borough of Mendham has also determined that it advisable to modify the name of the "Open Space, Recreation and Farmland and Historical Preservation Committee" to the "Open Space Committee," which is more commonly known as, to prevent confusion with the separate Recreational Committee.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Mendham, in the County of Morris and State of New Jersey, as follows:

SECTION 1. The name of the "Open Space, Recreation and Farmland and Historic Preservation Committee" is hereby changed to the "Open Space Committee." All references in the Borough Code to the "Open Space, Recreation and Farmland and Historic Preservation Committee" or "Open Space, Recreation and Farmland and Historic Preservation Trust Fund" should accordingly be changed to the "Open Space Committee" or "Open Space Trust Fund," respectively.

SECTION 2. Chapter 15, Environmental Commission, § 15-2, Members; qualification; terms of office; vacancies, is hereby amended to read as follows:

- A. The Environmental Commission shall consist of seven members and two alternate members (if such alternates are appointed) appointed by the Mayor. One member shall also be a member of the Borough Planning Board. Three members shall also be members of the Shade Tree Advisory Committee. All members shall be members of the Open Space Committee. All members shall be residents of the Borough of Mendham.
- B. Notwithstanding the membership requirements set forth in § 15-2A, the Environmental Commission, Shade Tree Advisory Committee, and Open Space Committee shall each retain its applicable statutory duties, powers, and functions as set forth in N.J.S.A. 40:56A-1 et seq., chapters 15, 35, and 54 of the Borough Code, and any other applicable law.

SECTION 3. Chapter 15, Environmental Commission, § 15-6, Meetings, is hereby amended to read as follows:

- A. Regular meetings of the Commission shall be held at the call of the Chairperson or, in his or her absence or disability, at the call of the Vice Chairperson.
- B. At all meetings a quorum shall consist of a majority of the members of the Commission.
- C. The Environmental Commission shall devote a reasonable portion of each meeting to discussion regarding Shade Tree Advisory Committee and Open Space Committee matters in accordance with § 15-2B.

BOROUGH OF MENDHAM MORRIS COUNTY, NEW JERSEY ORDINANCE 10-2018

SECTION 4. Chapter 35, Open Space Committee, § 35-1, Establishment, is hereby amended to read as follows:

There is hereby established an Open Space Committee which shall consist of seven members plus two alternates appointed by the Mayor with the advice and consent of the Borough Council and pursuant to § 15-2A. The members' terms and powers are hereinafter set forth.

SECTION 5. All ordinances of the Borough of Mendham, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 6. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 7. This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.
