CALL TO ORDER

Mayor Henry called the March 7, 2011 meeting of the Mayor and Council to order at 8:00p.m. in the Garabrant Center, 4 Wilson Street, Mendham, New Jersey.

Mayor Henry offered a moment of silence meditation, followed by the Pledge of Allegiance.

DISCUSSION:

Nursery School-Peggy Burke
-Sign (Permanent) Orchard Street

-Relocation of Sign-By Playground

Ms. Burke discussed the relocation of the present sign and how the request came about. Atty. Semrau noted that the property is owned by the Borough and there is case law supporting the governing body using their discretion with regard to these requests.

Atty. Semrau did caution that before the Council discusses and makes their recommendation, he would consult the Borough Engineer, Zoning Officer, and Board of Adjustment Attorney on behalf of the Borough. He stressed the need to be consistent, consideration given to traffic site issues and land use principles before further review at the Council level. It was further suggested that the neighbors near the property be notified of the Nursery School request for relocation of the sign.

DISCUSSION: (Cont'd.)

There was a brief discussion on the request for a permanent sign. Atty. Semrau suggested that Ms. Burke wait until the first sign request is decided. He also mentioned that Ms. Burke might need to seek the approval of the County Planning Board if the sign is to be placed on Main Street.

Sign Ordinance: Councilman Sharkey:

- -Illuminated- Councilman Sharkey commented that this was discussed during the sign ordinance meetings. After a brief discussion it was concluded that the Borough Zoning Officer will contact all businesses with these signs that are not grandfathered and have them removed. He will also provide a list of all businesses that are grandfathered, if any. This will be completed before the sign ordinance is introduced.
- -Freestanding (Tower) Council was in agreement that this would be a good alternative for the Kings Supermarket area. The Mayor suggested that Councilman Sharkey contact Mr. Diffen who can discuss this with the owner for his input.
- -Retail Farm Stand- There was discussion held with regard a sign and farm stand at the West Field location. Atty. Semrau noted that this property is deed restricted and neither of these requests would be allowed. He has reviewed the deed document in the past but will review again and report back to the Council

COUNCIL REPORTS, OLD & NEW BUSINESS:

Councilman Andrus commented that the he is waiting for the final figures from the Borough Auditor and Administrator before making any budget cuts.

Councilman Garubo asked the Council for their recommendations for a Grand Marshall.

Councilwoman Daly reported attending the Public Officials dinner and found the speakers to be very interesting.

Mayor Henry asked Councilwoman Daly to continue to share ideas for changes in the performance appraisal forms for the employee review process.

Mayor Henry noted that Councilman Badal is working on the promotional ordinance for the position of Police Chief.

ATTORNEY ITEMS:

Atty. Semrau reported that Councilman Witczak attended the public safety seminar sponsored by our insurance fund and the Borough received a \$250 credit. He further noted that the cable survey has been circulated and will be posted on the Borough web page, the email policy was sent to the Mayor and Council, and representative of the homeowners of Horseshoe Bend Road was notified regarding reimbursement for snow removal as approved by the Council. Atty. Semrau suggested the police promotional ordinance be reviewed by the Borough Labor Attorney before introduction. He concluded that he did attend but did not participate at the County Tax Board meeting with regard to the ratio-assessed value-fair market value argument. He will report any conclusions from that meeting as soon as they are received by him.

MAYOR'S ITEMS:

Mayor Henry commented on the Cable Survey for public input as a requirement in the renewal process. He reported meeting with Cit-E-Net for discussion on the cable survey, email boxes and an internet 'blast' capability. It was determined that the survey could be posted on the webpage for the resident to copy, complete and mail. Atty. Semrau suggested a 30 day period to complete and respond, for example 3/15-4/15. It was also suggested that the survey be posted Channel 25 and printed in the Mendham Messenger.

The email boxes will be discussed with other vendors and Cit-E-Net can provide a notification page where residents would be automatically notified on subjects that they have an interest in.

Mayor Henry asked and received Council approval for the Board of Chosen Freeholders to hold a public meeting in the Borough on September 26th, at 7:30PM at the Garabrant Center. He further reported that Charlie Nahabedian has retired and a replacement has been selected, another loop trail meeting was held and questions will be posted on the web page and there will be a meeting held at West Morris Central High School to determine if there will be a non-binding referendum regarding the funding formula placed on the ballot for the school board election.

PUBLIC COMMENT:

Dave Chakrin, First Aid Squad President, reported another good month with the Squad responding to 36 calls, 17 daytime and 19 at night.
