Disposition of Ambulance

The Council discussed the appropriate disposition of the old ambulance once the new one is delivered. Mr. Hendren confirmed that the value of the old ambulance is approximately \$3,000 and proposed that it be used as a pre-loaded support vehicle for emergency situations. The Council agreed that the OEM Coordinator would have use of the current Water Reclamation Facility truck once a new vehicle is delivered.

Councilman Andrus made a motion to approve the use of the ambulance as a support vehicle and clarified that the Borough would not be providing a storage building for it. The motion was seconded by Councilman Sharkey. On a voice vote, all were in favor. Mr. Bracco thanked the Mayor and Council for their consideration.

False Alarm Fees

ADMINISTRATOR REPORT

The Administrator's report was distributed to the Mayor and Council previously.

Councilman Andrews asked if estimated costs and a start date were available for the tennis court improvement project. Mr. O'Brien confirmed that the Financial Committee has budgeted \$50,000 for repairs to the firehouse courts and for repaving of the cracks on the Orchard Street courts.

COUNCIL REPORTS, OLD & NEW BUSINESS

Councilman Andrews – Three (3) candidates have been identified for Zoning Officer interviews which will be scheduled over the next couple of weeks. All Council Members are invited to participate in the interview process. The final candidate recommendation will be provided in writing to the Council.

Councilman Badal - excused.

Councilwoman Daly - excused.

Councilman Sharkey – Little League opening day was very successful and Detective Irons dedicated the scoreboard during the festivities. The Shade Tree Commission is planting last year's seedlings and the photography contest winner, Carrie Vallacchi, will have a tree planted on/near her property to enhance the streetscape. Seedling distribution will be May 2-9, 2016 and Mr. O'Brien will have a DPW employee available on the Saturday, if necessary. Attendance was high at the Environmental Commission's 3River Festival which included music, poetry reading and artwork. Criteria and candidates for the Labor Day Grand Marshal will be available for the May 2nd Council meeting.

Councilman Witczak - excused.

Councilman Andrus – The shared-court meeting with Chester was very productive and the 2015 savings were in excess of \$40,000. Mendham Township has asked to participate in the shared service; accordingly data and information are being gathered. Both the Borough and Chester would have to agree to allow the Township to join.

Mayor Henry will be working with the Board of Education to arrange for a 2nd joint meeting to discuss re-regionalization of the school district. Mr. O'Brien will work with the Environmental Commission to coordinate a Borough shredding event. During the shared-court meeting with Chester, shared services for sewer and IT were discussed.

Mayor Henry opened the floor to comments/questions from the public.

Charles Topping, Aberdeen Drive, proposed a $110^{\rm th}$ anniversary celebration featuring former resident Abner Doubleday and suggested that signs or historical markers be placed in and around the Borough. Mr. Merkt agreed to follow up with the County regarding possible signage.

Pat Serrano, Maple Avenue, confirmed that the MBA sponsored Abner Doubleday Day on May 11, 1996 during which there was a parade, an old-timers baseball game and Civil War reenactments.

Elizabeth Drake, Cold Hill Road, offered the Historical Society's assistance for any event that may be planned for the 110^{th} anniversary.

Mr. Merkt agreed to look into a possible Abner Doubleday event during Little League playoffs.

Hearing no additional comments, Mayor Henry closed the public portion of the meeting.
