Discussion: Councilman Andrus expressed his opposition to the use of Open Space funds to repair a dam and feels this is misuse of the public trust. He reported that he has spoken with members of the Open Space Committee who, no all, overwhelmingly opposed, use of open space funds for this purpose. Administrator Sandman responded that Atty. Semrau reviewed our open space ordinance and the use of funds for this purpose was permitted and disagreed that this was a misuse of funds. She stressed, for the record, that she would not be in support of an action that would entail the misuse of funds.

Mayor Henry commented that West Milford resisted the DEP in repairs to their dam and the DEP came in and did the work and billed the municipality. Councilman Sharkey received clarification that the \$28,000 would be for a study to be done by Borough Engineer Paul Ferriero. He further commented that the wording "maintain open space" in the ordinance is 'broad'. Councilman Badal commented that this was action requested by the DEP and felt that the Borough has no choice but to comply.

Councilman Badal asked for the response from Comcast regarding the removal of the black boxes on the utility poles in Mendham that was asked by resident Frank Lupo at the last meeting. The Admnistrator responded that she did not make contact yet with Comcast but will do so by the next meeting. Councilman Badal, with agreement from the Mayor, requested that the bill list be circulated no later than the Wednesday before the meeting as previously requested by the Council.

# **COUNCIL REPORTS, OLD & NEW BUSINESS:**

Councilwoman Daly reported that she just attended interviews with 3 very qualified for position of Borough Planner. She concluded that the employee evaluation form is being reviewed by the Administrator.

Councilman Sharkey reported that the sign ordinance is in the final stages and will be sent to the Planning Board for review. He further reported that 14 trees have been planted throughout the Borough.

Councilman Andrus received a recommendation to increase the cat/dog license fees. It was noted that construction code fees and use of police vehicles for special duty should also be considered when amending the fee ordinance.
