#19-2021 ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING THE PURCHASE OF VACANT REAL PROPERTY LOCATED ON A PORTION OF BLOCK 601, LOT 5 (MENDHAM METHODIST CHURCH) IN ACCORDANCE WITH N.J.S.A 40A:12-5

Summary: This ordinance will finalize the purchase of approximately 1.6666 acres of vacant land from the Mendham Methodist Church. Resolution #141-2021, adopted on October 25, 2021 authorized the Contract of Sale. The purchase will be funded by \$220,000 from the Morris County Open Space Trust Fund and \$80,000 from the Mendham Borough Open Space Trust Fund.
