VIII. Health Officer's and Health Education Reports for February 2022

Ms. Dowd summarized the Health Officer's reports and Education reports for February 2022. These

reports are on file with the Board of Health Secretary. President Althoff asked for clarification as to what the VNA do. Ms. Dowd stated that the Bernards Health Department set up the clinics and the VNA are the nurses that administer the vaccines, screenings, home visits, etc.

Mr. Brooks asked if there has been any influenza clinics. Ms. Dowd stated that there were very small clinics this year and plan to expand to more locations. President Althoff spoke to Lucy at Bernards and stated that most of the shots for flu are be administered at drug stores. Mr. Rostiac asked if there is enough being done to get the word out on the clinics. Ms. Dowd stated that they put out a sign in front of the Bowers Building and is placed in the newspaper. Mr. Nosta suggested having the Bernards Health Department do the advertising of the clinics. Ms. Young suggested putting the information in the Messenger each month. President Althoff asked for volunteers to look at the Borough's website and see if there is additional information that needs to be added. Ms. Young volunteered to look over the website. President Althoff asked Ms. Dowd to supply a list of monthly activities that Bernards is having so that these items can be put in the Mendham Messenger and sent to the residents via email notification.
