7. ORDINANCE FOR PUBLIC HEARING AND ADOPTION

#01-2023 ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 215, ZONING, OF THE BOROUGH CODE TO PERMIT CERTAIN RESIDENTIAL BUILDING ENCROACHMENTS FOR HOME IMPROVEMENTS

Summary: Owners of residential properties in certain areas of the Borough are restricted in constructing home improvement projects, such as patios or decks, due to existing setback limitation which require them to seek formal variance relief.
