Summary: On August 5, 2022, Governor Murphy signed into law Senate Bill 1368, which mandates

that business owners, rental unit owners, and certain multi-family homeowners maintain liability insurance for negligent acts and omissions in amounts set forth in N.J.S.A. 40A:10A-1; and Senate Bill 1368 additionally requires such business, rental unit and certain multi-family home owners to annually register a Certificate of Insurance with the municipality in which the business, rental unit, or multi-family home is located, in

accordance with N.J.S.A. 40A:10A-2a, effective November 3, 2022.
