# BOROUGH OF MENDHAM MEETING OF THE MAYOR AND COUNCIL APRIL 24, 2023 7:00PM MINUTES

# CALL TO ORDER

Mayor Serrrano Glassner called the April 24, 2023, Regular Meeting of the Mayor and Council to order at 7:00 p.m. in the Garabrant Center, 4 Wilson Street, Mendham, New Jersey.

#### FLAG SALUTE AND MOMENT OF SILENCE

Mayor Serrano Glassner led a moment of silence and proceeded with the Pledge of Allegiance. Council Member Andrews recognized Mr. Ernst Walksmith who grew up in the Borough and member of the Pastime Club who recently passed away.

Mayor Serrano Glassner asked Council if it would be acceptable to move the Budget Presentation up in the Agenda order and also move the Discussion Item following Resolutions. Council was in agreeance.

#### CY2023 BUDGET PRESENTATION

Mr. Bud Jones, Mendham Borough Auditor presented the 2023 Budget to Mayor and Council. Council President Reilly asked Mr. Bud Jones for clarification relating to a variation that appeared to exist between certain totals in the State budget spreadsheet and the budget presentation. Mr. Bud Jones explained that the spreadsheet page Council President Reilly was referring to is a template form the State that the Borough cannot edit and that should be disregarded. Council President Reilly stated that he had not had time to figure out the discrepancy and was not sure how to proceed to review the Budget document. Mr. Bud Jones advised Council President Reilly that he is available at any time to review the Budget in detail. Council Member Sullivan asked Mr. Bud Jones for clarification on what I-Bank is, and Mr. Bud Jones provided an explanation of the State Infrastructure Loan program.

#### #070-2023 RESOLUTION TO ADOPT THE 2023 MUNICIPAL BUDGET

Council Member Badal stated there are certain lines in the Budget relating to legal expenses that he questioned during the budget introduction, and that at that time, Ms. Joyce Bushman had answered his questions. Council Member Badal stated that while he cannot go into detail because of confidentiality, there is certain litigation that he feels the Borough should not be involved in and that the money could be better spent on taxpayers. Council Member Badal stated he will be voting "no" on the adoption of the Budget.

Council President Reilly stated he did not have time to fully review the budget and that he will be setting a time to review with Mr. Bud Jones.

The budget was provided to Mayor and Council prior to the Introduction of the Budget on March 27, 2023.

Council Member Andrew stated he agreed with Council Member Badal on a couple items he discussed.

Mayor Serrano Glassner opened Public Hearing.

Seeing and hearing no one wishing to be heard, Mayor Serrano Glassner closed public comment.

# DISCUSSION ITEM

Council discussed West Main 21, LLC application for Sanitary Sewer Connection. Mr. Paul Ferriero, PE, Borough Engineer recommended designating one unit Affordable Housing. Sewer capacity is limited based on what needs to be reserved for the V-Fee project behind King's. Council agreed that one unit should be designed Affordable Housing and asked Ms. Sue Sharpe, Esq., Borough Attorney to prepare a Resolution for such.
