Mr. Shofe gave an overview of the application for the fence replacement. The Shofe's are proposing to install a 6-foot cedar privacy fence on the left side 21 feet out from the house and 24 feet down the side of the house, transitioning to a 4-foot vinyl picket fence. On the right side, the garage and foliage would mask the vinyl fence that would start approximately 160 feet from the street. Mr. Shofe feels that the vinyl on that side would not be seen from the street.

After discussion the Commission asked the Shofe's to look into a wooden type fence to replace the section proposed as vinyl.

**Motion** was made by Ms. Shafran, **seconded** by Mr. Van Arsdale to approve only the cedar fence portion outlined in red on the survey of the application.
