MINUTES OF THE APRIL 17, 2023
REGULAR MEETING**

CALL TO ORDER/FLAG SALUTE:

The regular meeting of the Historic Preservation Commission was called to order at 7:30PM and the open public meetings statement was read into the record.

Mr. Encin recused himself.

Mr. Encin explained the application and plans to construct a two-family house at 29 Hilltop Rd on the existing foundation that were submitted with the application. The proposed structure will have a centralized peak with a steep pitch along with a smaller matching decorative dormer. Mr. Encin went over the materials that will be used for the project that are noted on the plans. The front door will be painted wood with simulated divided light window. Mr. Encin stated that the 2 family is not 1st and 2nd floor design, it is a front and back design to maintain the single-family look. Mr. Encin explained that the one family that fronts Hilltop Rd will have entry access using the front door and will use the detached garage and the second family will access the house through the attached garage.

Mr. Maresca questioned if there would be chimneys. Mr. Encin explained that if there were any fireplaces installed, they would be direct vent. Mr. Van Arsdale asked if the basement would still be utilized, and Mr. Encin stated that it would be. Ms. Rodrigues asked if there was a color picked. Mr. Misko stated that he hasn't picked a color yet.

Motion was made by Ms. Shafran, seconded by Ms. Rodrigues to approve the application as submitted.
