# **HEARING OF CASES**

<u>deNeufville, Peter</u> – Extension to previously approved variance Block 1801, Lot 37, Thomas Road

Present: Peter deNeufville, Applicant

Mr. Germinario, Esq. presented the background stating that the applicant was granted a D2 variance for the expansion of a guest house on December 7, 2010. The action was memorialized on January 4, 2011. The applicant was now requesting an extension which he believed could be granted if the applicant showed good cause. In this case, approvals from the Morris County Soil Conservation District and the Health Department are pending.

Mr. deNeufville stated that he had received a letter from the Board Engineer in December 2011 indicating that approval from the Bernards Health Department was required as part of the conditions to obtain a building permit. They filed with the Health Department last month. The Morris County Soil Conservation District has provided their approval. He is not sure of the status of the septic at this time.

Mr. Seavey stated that in the past that as long as nothing significant has changed in conjunction with the zoning or the neighbors, the Board has granted extensions. Unless the Board had any objections, he would be supportive.

Responding to Mr. Germinario, Mr. deNeufville advised the Board that he is requesting one year. They applied for the building permit in July.

Mr. Germinario, Esq. introduced the following resolution to the Board:

#### IN THE MATTER OF PETER de NEUFVILLE EXTENSION OF VARIANCE APPROVAL BLOCK 1801, LOT 37

**WHEREAS,** Peter de Neufville (hereinafter known as the "Applicant") obtained approval from the Mendham Borough Zoning Board of Adjustment (hereinafter known as the "Board") by Resolution dated January 4, 2011, for a variance pursuant to N.J.S.A. 40:55D-70d(2), to enlarge a non-conforming accessory building (the "Variance"); and

**WHEREAS,** pursuant to Condition 3 of the Resolution and Ordinance §124-22, the Variance expired as of January 3, 2012; and

**WHEREAS,** the Applicant has requested from the Board an extension the Variance for an additional period of one year; and

**WHEREAS,** a public hearing was held on February 7, 2012, no notice being required; and

**WHEREAS,** the Board has determined that the requested extension of the Variance is justified based on the Applicant's need to obtain approvals from the Bernards Township Health Department and the Morris County Soil Conservation District.

**NOW, THEREFORE, BE IT RESOLVED,** that the Board does hereby grant the requested extension of the Applicant's Variance approval for an additional period of one year.

Mr. Peralta made a motion to approve the extension of one year and the resolution. Mr. Ritger seconded.
