1. CALL TO ORDER

Mayor Serrano Glassner called the August 26, 2024, Regular Meeting of the Mayor and Council to order at 7:00 p.m. in the Garabrant Center, 4 Wilson Street, Mendham, New Jersey.

6. PRESENTATION

1. Mackenzie Kay presented her Girl Scout Silver Project, "Mendham Maps". She plans to place two map kiosks at the Dean Rd and Knollwood Dr entrances of Patriots Path. The maps are intended to help guide people along the trails and provide information about Mendham.

Council Members Sullivan and Russo commended Ms. Kay on her project.

Mayor Serrano Glassner asked for a motion to approve the project. Member Russo made a motion to approve, and it was seconded by member Sullivan. All were in favor.

2. Karl Maurer presented his Eagle Scout Project, "Flag Collection Boxes". He plans to build boxes for collecting flags in need of retirement. Flag collection boxes will be placed at the police station and the Phoenix House.

Council Members Althoff and Russo commended Mr. Maurer on his idea. Mayor Serrano Glassner asked Mr. Maurer to please submit his budget to Lauren McBride, Acting Borough Clerk.

#11-2024 AN ORDINANCE AMENDING CHAPTER 38 OF THE CODE OF THE BOROUGH OF MENDHAM, ENTITLED "POLICE DEPARTMENT"

Jon Alpern of 30 Phoenix Dr read a statement from the Mendham First Aide Squad. They are not in favor of Ordinance 11-2024, section 38-22, item D.

Richard Pace of 5 Forest Drive asked what is the benefit? Why would you have a non-police professional running the department?

Borough Attorney, Fred Semrau stated that the Public Safety Director position works to facilitate growth within the police department. They are usually retired chiefs of police. They coordinate with the governing body new ideas to make the department stronger. It is not a permanent position. They will help the department grow during this transitional time. To prepare before the next chief is appointed.

Tom Rudd of 15 Hoffman Rd asked, what is the cost? What is the value? Is this the standard for when someone retires?

The mayor stated that the position is not intended to be permanent. It is to help the department grow and prepare for the future.

Carol Pace of 5 Forest Drive asked, why are you doing this? What are you looking for that we do not have?

Ken Lordy of 17 Florie Farm Rd stated he didn't realize this position was an interim position. He would like to add that the position is interim to the ordinance.

Jon Alpern of 30 Phoenix Drive stated the ordinance states there cannot be a chief of police and public safety director simultaneously.

Council member Bruin stated that he is in favor of the public safety director position on a short-term contract basis.

Council member Russo stated that he is in support of the position as a short term to establish a long-term plan.

Council member Althoff explained that the public safety committee is in agreement that the position is short term.

Mayor Serrano Glassner asked for a motion to approve the ordinance with the change of "shall" to "may" in section D.
