## **ORDINANCE #09-2025**

ORDINANCE AMENDING THE CAPITAL APPROPRIATION ORDINANCE 03-2025 ADOPTED MAY 12, 2025, OF THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY

**BE IT ORDAINED** BY THE BOROUGH OF MENDHAM COUNCIL, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

Section 1. The Capital Appropriation Ordinance # 03-2025, adopted May 12, 2025 "Providing For Various Improvements or Purposes to be Undertaken in and by The Borough Of Mendham, in the County Of Morris, New Jersey, and Appropriating \$355,000 therefor from Various Funds of the Borough" to the extent of \$210,000 from the Capital Improvement Fund within the General Capital Fund; to the extent of a \$67,000 from the State New Jersey Department of Community Affairs, 2024 Local Recreational Improvement Grant; to the extent of a \$28,000 from the County of Morris, 2024 Morris County Open Space Fund Trail Construction Grant; to the extent of \$50,000 from the Borough of Mendham Open Space Trust Fund is amended to include Section 02 (e) and hereby by appropriate an additional \$42,060.00 to the extent of \$42,060.00 from a Community Development Block Grant awarded through the County of Morris, New Jersey, Department of Human Services, Division of Community and Behavioral Services, Office of Community Development.

"Section 2. The improvements hereby authorized and the several purposes for the financing of which the appropriation is made as provided in Section 1 of this ordinance are amended to include Section 2 (e) together with for all the aforesaid all paving, curbing, drainage improvements, milling, Belgium blocks, engineering, equipment, site work, structures, appurtenances, work, materials and other expenses necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Borough Clerk of this ordinance.

- (a) \$85,000 for Engineering Services for Ironia Road improvements. (To the extent of \$85,000 from the Capital Improvement Fund.)
- (b) \$125,000 for the Annual Street Repaying Program improvements of various roads in and by the Borough for the resurfacing and paying thereof. (To the extent of \$125,000 from the Capital Fund.)
- (c) \$110,000 for various improvements to the existing Patriot's Path Trail between Mountain Ave and India Brook. (To the extent of a \$67,000 from the State New Jersey Department of Community Affairs 2024 Local Recreational Improvement Grant, and to the extent of \$43,000 from the Borough of Mendham Open Space Trust Fund.)
- (d) \$35,000 for the Borough Park and Arboretum Trail-Phase I Design (To the extent of a

\$28,000 grant from the County of Morris, 2024 Morris County Open Space Fund Trail Construction Grant for the Borough Park and Arboretum Trail-Phase I-Design, and to the extent of \$7,000 from the Borough of Mendham Open Space Trust Fund.)

(e) \$42,060.00 for Police Station ADA Accessible Doors. (To the extent of 42,060.00 from a Capital Development Block Grant awarded though the County of Morris, New Jersey, Department of Human Services, Division of Community and Behavioral Services, Office of Community Development)

**Section 3.** The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

**Section 4.** This ordinance shall take effect after publication after final passage as provided by law.
