ORDINANCE #12-2024

**ORDINANCE AMENDING AN APPROPRIATION
ORDINANCE OF THE BOROUGH OF MENDHAM, IN
THE COUNTY OF MORRIS, NEW JERSEY,
HERETOFORE ADOPTED ON APRIL 12, 2023 (#05-2023).**

**BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH
OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:**

Section 1. The appropriation ordinance of The Borough of Mendham, New Jersey (the “Borough”), heretofore adopted by the governing body thereof on April 12, 2023 and entitled: “Ordinance providing for various improvements or purposes to be undertaken by the Borough of Mendham, in the County of Morris, New Jersey, and appropriating \$1,171,790 therefor from various funds of the Borough” (#05-2023), is hereby amended to the extent and with the effect that Section 2 thereof shall read as follows (revised text is underscored):

“Section 2. The improvements hereby authorized and the several purposes for the financing of which the appropriation is made as provided in Section 1 of this ordinance are as follows: (a) the improvement of various roads and curbs in and by the Borough (\$336, from funds available in the Current Fund); (b) the improvement of Phoenix Drive and Knowlwood Drive in and by the Borough (\$280,815, to the extent of \$199,815, from the NJDOT grant and to the extent of \$90,000, from funds available in the Current Fund); (c) the renovation of the Phoenix House by the structural improvements thereof (\$627,975, to the extent of \$279,410 from the Morris County Historical Preservation Trust Fund, and, to the extent of \$348,565, from the New Jersey Historic Trust); and (d) the acquisition of a new fire truck (\$253,664, from the American Rescue Plan of 2021 grant), together with for all the aforesaid all paving, curbing, drainage improvements, milling, Belgium blocks, engineering, equipment, site work, structures, appurtenances, work, materials and other expenses necessary

therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.”

Section 2. The capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Borough Clerk and are available for public inspection.

Section 3. The Finance Committee of Council has reviewed and recommends the amendments in Section 1.

Section 4. This ordinance shall take effect after publication after final adoption, as provided by law.
