## **ORDINANCE #13-2024**

ORDINANCE AMENDING AN APPROPRIATION ORDINANCE OF THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, HERETOFORE ADOPTED ON OCTOBER 24, 2022 (#09-2022).

## BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

Section 1. The appropriation ordinance of The Borough of Mendham, New Jersey (the "Borough"), heretofore adopted by the governing body thereof on October 24, 2022 and entitled: "Ordinance providing for various capital improvements or purposes to be undertaken in and by the Borough of Mendham, in the County of Morris, New Jersey, and appropriating \$1,263,000.00 therefor from various funds of the Borough" (#09-2022), is hereby amended to the extent and with the effect that Section 2 thereof shall read as follows (revised text is underscored):

"Section 2. The improvements hereby authorized and the several purposes for the financing of which the appropriation is made as provided in Section 1 of this ordinance are as follows: (a) the purchase of SCBA Bottles for the Fire Department (\$75,000); (b) the addition of a storage building for the First Aid Squad (\$25,000); (c) the improvement of the Phoenix House parking lot (\$25,000); (d) the improvement of the Department of Public Works facilities, including the demolition, engineering and building of the Equipment Cold Storage Building (\$235,000); (e) the purchase of a Brush Chipper for the Department of Public Works (\$85,000); (f) the purchase of a Ball Field Groomer for the Department of Public Works (\$30,000); (g) the purchase of a Alco Tester Unit for the Police Department (\$34,000); (h) the improvement, resurfacing and paving, of various roads within the Borough (<u>\$450,336</u>); (i) allocation for the future purchase of a Fire Rescue Pumper Truck for the Fire Department (\$50,000); <u>and (j) the</u>

<u>purchase of a new fire truck (\$253,664)</u>, together with for all the aforesaid all equipment, site work, structures, appurtenances, work, materials, and other expenses necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved."

Section 2. The capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services are on file with the Borough Clerk and are available for public inspection.

Section 3. The Finance Committee of Council has reviewed and recommends the amendments in Section 1.

Section 4. This ordinance shall take effect after publication after final adoption, as provided by law.
