**ORDINANCE #17-2024**

**ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY,  
AMENDING CHAPTER 206 OF THE BOROUGH CODE TO PROHIBIT PARKING ON A  
DESIGNATED PORTION OF IRONIA ROAD**

**WHEREAS**, the Borough of Mendham Police Department, Administration, and Public Safety Committee have reviewed and recommended amending the Borough Code to prohibit parking along the east side of Ironia Road from Mountainside Road to Route 24 (West Main Street).

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Mendham, in the County of Morris and State of New Jersey, as follows:

**SECTION 1.** Chapter 206, Vehicles and Traffic, Article XIV, Schedules, § 206-43, Schedule I: No Parking, is hereby amended to add the following road:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Ironia Road	East	Mountainside Road to Route 24 (West Main Street)

**SECTION 2.** All ordinances of the Borough of Mendham that are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 4.** This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.
