ORDINANCE #05-2025

**ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY,
AMENDING CHAPTER 206 OF THE BOROUGH CODE TO ESTABLISH TURN RESTRICTIONS ON
DESIGNATED PORTIONS OF MAIN STREET AND HILLTOP ROAD**

WHEREAS, the Borough of Mendham Police Department and Administration have recommended amending the Borough Code to establish turn restrictions on designated portions of Main Street and Hilltop Road.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Mendham, in the County of Morris and State of New Jersey, as follows:

SECTION 1. Chapter 206, Vehicles and Traffic, Article XIV, Schedules, § 206-56, Schedule XIV: Prohibited Turns at Intersections, is hereby amended to read as follows.

Name of Street	Direction of Travel	Prohibited Turn at Intersection of
Main Street	East	No Right Turn at New Street 6:00 a.m. to 9:00 a.m., Monday through Friday
Hilltop Road	North	No Left Turn at Prospect Street 3:00 p.m. – 6:00 p.m. Monday through Friday

SECTION 2. All ordinances of the Borough of Mendham that are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 4. This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.
