ORDINANCE #14-2026

ORDINANCE PROVIDING FOR THE CLOSURE OR LINER REPLACEMENT OF POLISHING LAGOONS AND 3 MONITORING WELLS IN AND BY THE BOROUGH OF MENDHAM, IN THE COUNTY OF MORRIS, NEW JERSEY, AND REAPPROPRIATING \$462,472.00 THEREOF FROM AVAILABLE SEWER CAPITAL FUNDS AND APPROPRIATING \$112,528.00 THEREFOR FROM THE SEWER CAPITAL IMPROVEMENT FUND OF THE BOROUGH OF MENDHAM

BE IT ORDAINED BY THE BOROUGH OF MENDHAM COUNCIL, IN THE COUNTY OF MORRIS, NEW JERSEY, AS FOLLOWS:

Section 1. The improvements described in Section 2 are hereby authorized as general improvements to be made or acquired by The Borough of Mendham, New Jersey; and The Borough of Mendham Council has determined that it is in the best interest of the Borough that the sum of \$462,472.00 shall hereby be reappropriated from the Sewer Capital Fund from funds available under Borough ordinances #06-2022 (b) improvements to the Franklin Street Pumping Station (\$312,472.94), #06-2023 (a) the upgrade of the Franklin Street Pump Station (\$100,000.00), and #05-2024 (a) the upgrade of the Franklin Street Pump Station (\$50,000.00) heretofore adopted and not necessary for the purposes for which appropriated; and there is hereby appropriated therefor the sum of \$112,528.00 from moneys available in the Sewer Capital Improvement Fund of the Borough.

Section 2. The improvements hereby authorized and the purpose for which the \$462,472.00 reappropriation and the \$112,528.00 appropriation is made in Section 1. Is as follows:

- (a) The closure or liner replacement of Polishing Lagoons and 3 monitor wells together with all studies, designs, surveys, equipment, appurtenances, attachments, work, materials and other expenses necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final passage as provided by law.
