ORDINANCE #19-2024

**ORDINANCE OF THE BOROUGH OF MENDHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY,
AMENDING CHAPTER 206 OF THE BOROUGH CODE TO AMEND PARKING RESTRICTIONS ON
DESIGNATED PORTIONS OF EAST MAIN AND WEST MAIN STREETS**

WHEREAS, the Borough of Mendham Police Department and Administration have recommended amending the Borough Code to amend parking restrictions on designated portions of East Main and West Main streets.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Mendham, in the County of Morris and State of New Jersey, as follows:

SECTION 1. Chapter 206, Vehicles and Traffic, Article XIV, Schedules, § 206-43, Schedule I: No Parking, is hereby amended to modify parking restrictions on East Main Street and West Main Street to read as follows. All other listings shall remain unchanged.

Name of Street	Side	Location
East Main Street	Both	From Fire House Driveway to Halstead Street
East Main Street	Both	From Temple Wick Road to Cold Hill Road (Pitney Road)
East Main Street	North	From Mountain Avenue to a point 210 feet east of Mountain Avenue
East Main Street	North	From Manor Drive (also known as Heritage Manor Drive) to Dean Road
East Main Street	North	Mountain Avenue to a point 150 feet west of Mountain Avenue
East Main Street	South	From Hilltop Road to a point 100 feet easterly therefrom
East Main Street	South	From the intersection of Temple Wick Road to a point 200 feet west thereof
West Main Street	Both	From Ironia Road to the intersection of Linden Lane/North Linden Lane
West Main Street	North	From Mountain Avenue to a point 110 feet west thereof
West Main Street	South	Hilltop Road to a point 200 feet west thereof

SECTION 2. Chapter 206, Vehicles and Traffic, Article XIV, Schedules, § 206-44, Schedule II: No Parking Certain Hours, is hereby amended modify parking restrictions on East Main Street and West Main Street to read as follows. All other listings shall remain unchanged.

Name of Street	Side	Location
East Main Street	North	7 a.m. to 9 a.m. & 2 p.m. to 4 p.m. From a point 210 feet east of Mountain Avenue to Fire House driveway

East Main Street	South	7 a.m. to 9 a.m. & 2 p.m. to 4 p.m.	From a point 100 feet east of Hilltop Road to Fire House driveway Hillcrest Road to Dean Road
East Main Street	South	7 a.m. to 9 a.m. & 2 p.m. to 4 p.m.	From Dean Road to a point 200 feet West of Tempe Wick Road
West Main Street	North	7 a.m. to 9 a.m. & 2 p.m. to 4 p.m.	New Street to a point 110 feet west of Mountain Avenue
West Main Street	South	7 a.m. to 9 a.m. & 2 p.m. to 4 p.m.	New Street to a point 200 feet west of Hilltop Road

SECTION 3. All ordinances of the Borough of Mendham that are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 4. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 5. This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.
