**RESOLUTION #119-2025**

**RESOLUTION AWARDING A CONTRACT FOR THE 2024 NJDOT LOCAL AID GRANT FOR GUNTHER STREET CAPITAL IMPROVEMENT PROJECT TO DLS CONTRACTING, INC. AND DLS CONFIRMATION OF CONSTRUCTION START DATE FOR PHOENIX AND KNOWLWOOD DRIVE PROJECT REPAIRS**

**WHEREAS**, the Borough of Mendham was awarded an NJDOT Local Aid Grant for \$234,567.00; and

**WHEREAS**, the Borough of Mendham solicited bids for the Gunther Street Road Improvements Project; and

**WHEREAS**, seven sealed bids were received and opened on June 11, 2025, in accordance with the advertised date for acceptance of bids; and

**WHEREAS**, the lowest apparent bid was from DLS Contracting, Inc. in the amount of \$337,841.85; and

**WHEREAS**, the Borough Engineer has reviewed the design of the project and found it to be in compliance with applicable roadway design and stormwater standards; and

**WHEREAS**, Boswell Engineering has reviewed the bid from DLS Contracting, Inc., found that it complies with the required technical specifications, and per correspondence dated June 17, 2025, recommended awarding the bid to DLS Contracting, Inc., subject to CFO certification and review by the Borough Attorney, **and subject to the confirmation by DLS Contracting, Inc. of the construction start date to make the Phoenix and Knollwood Drive Project repairs, prior to execution of the contract; and**

**WHEREAS**, the Borough Attorney has reviewed the bid from DLS Contracting, Inc. and determined that it is substantially in proper form and in compliance with the provisions of the Local Public Contracts Law, N.J.S.A. 4A:11-1 et seq., rendering DLS Contracting, Inc. the lowest responsive, responsible bidder; and

**WHEREAS**, the Borough's Chief Financial Officer has certified that sufficient funds are available for this contract.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Mendham, County of Morris, State of New Jersey, as follows:

1. The Borough Council hereby awards a contract to DLS Contracting, Inc. for the Gunther Street Road Improvements Project in an amount not to exceed \$337,841.85, in accordance with its bid.
2. The Borough engineer has reviewed the design of the project and found it to be in compliance with applicable roadway design and stormwater standards.
3. The Mayor and Borough Clerk are hereby authorized and directed to execute said contract.
4. This Resolution and contract shall be available for public inspection in the office of the Borough Clerk.

This resolution shall take effect immediately.
